GAMBLING ACT 2005 GAMBLING COMMISSION UPDATE GAMBLING POLICY REVIEW

The Gambling Act 2005 came into force in 2007 and brought in a new comprehensive system for gambling regulation in Great Britain. The Act established a dedicated regulator at national level, in the form of the Gambling Commission. It also gave responsibility to local authorities for regulating gambling at a local level.

Licensing Authorities have responsibility for licensing gambling premises within their area, as well as undertaking functions in relation to lower stake gaming machines and processing temporary and occasional use notices.

Licensing Authorities are also required to produce a Gambling Policy and to review it every three years. Carmarthenshire is currently undertaking a consultation exercise as part of reviewing our current Gambling Policy. Copies of the consultation documents are attached.

Members of the committee, who have not already responded are encouraged to complete the attached response form. The consultation closes on the 1st of June 2018.

The Gambling Commission Compliance Manager has agreed to attend the meeting to provide members with an overview of Gambling Regulation.

Statement of gambling licensing policy A councillor's guide (England & Wales only)

It is a legal requirement for each licensing authority (LA) to prepare a Statement of Policy they propose to apply in exercising functions under the Gambling Act 2005.

It must be reviewed every 3 years. All LAs are required to publish a revised Statement in January 2019. This applies even if amendments have been made during the 3 year period.

The Gambling Act 2005

There are three licensing objectives under the Act. Keeping crime out of gambling, ensuring it is fair and open and protecting children and other vulnerable people from being harmed by gambling.

There are 4 principles to inform a licensing authority as to how it carries out its duties:

- our codes of practice that apply to licensed gambling operators and to pubs and clubs
- our Guidance to Licensing Authorities
- · the licensing objectives above
- · Your own Statement.

The Statement

The function of the Statement is to reflect **locally specific** gambling concerns and to reflect the Council's wider strategic objectives. The active use of the Statement is one means by which you can make clear your expectations of gambling operators who have premises in your area.

This allows operators to respond to locally specific requirements and adjust their own policies and procedures as required. It also reduces the risk of matters being escalated to a licensing committee.

But we don't get any complaints!

It may well be the case that you receive very few, or no complaints about gambling. You are highly unlikely to do so.

Unlike other regulated areas, such as alcohol or drugs, gambling is much less visible as a concern for residents. The problem gambler or the under 18 who gambles are very unlikely to contact you or the LA to complain. The nature of co-regulation requires both LAs and the Commission to engage in inspection and enforcement. Unless an LA proactively conducts inspections you will not know what the true compliance picture looks like. Critically, you have no means of knowing whether the necessary protections, especially for the young and vulnerable, are in place and working effectively.

Importantly, unless inspections and enforcement against illegality are conducted it unfairly penalises those who are complete 34



Consult with responsible authorities

The Act specifies a list of responsible authorities with whom you must consult (s157). Along with those you'd expect such as police, you must include a body whose functions include the protection of children from harm. You might consider your **Safeguarding Board**.

Another body which can also help to inform the strategic picture and approach as well as inform the local area profile (LAP) is **Public Health**. Given the range of co-morbidities associated with addictions it is likely that some of those presenting with one specific condition may be experiencing gambling-related harm as well.

Local area profile (LAP)



You should develop a 'heat map' or local area profile of your council area. Completion of a LAP is not a requirement but there are significant benefits for both the LA and businesses in having a better awareness of the local area and risks (both potential and actual).

An effective LAP is likely to take account of a wide range of factors, data and information already held by the LA and its partners.

Gambling operators' responsibilities

Licence conditions and codes of practice (LCCP) issued by the Commission formalise the need for operators to consider local risks.

Social responsibility code 10.1.1 requires licensees to assess the local risks to the licensing objectives posed by the provision of gambling facilities at each of their premises, and have policies, procedures and control measures to mitigate those risks. In undertaking their risk assessments, they must take into account relevant matters identified in the LA's Statement.

A licensing authority can request that the licensee share a copy of its own risk assessment which will set out the measures the licensee has in place to address specific concerns.

How is gambling regulation financed?

Compliant businesses would rightly expect their fees to be (partly) spent on the pursuit of the non-compliant and the illegal.

LAs in England and Wales can set their own gambling fees but 'shall aim to ensure that the income from fees... as nearly as possible equates to the costs of providing the service to which the fees relates'. DCMS set an upper limit for premises fees in England and Wales.



Unless an LA can provide the necessary justifications, where income exceeds expenditure, or vice versa, there should be an adjustment of fees levels to bring them into balance. Fees should be reviewed annually.

Gambling Policy Review Consultation Document April 2018

 This consultation document provides an opportunity for you to contribute to the review of Carmarthenshire's gambling policy. We look forward to receiving your comments and ideas to ensure that we are able to maintain an effective licensing system for Carmarthenshire.

Introduction

- 2. The current policy, which was adopted by the Authority in February 2016, must be reviewed at least every three years to ensure that it reflects feedback from the local community that the statutory objectives are being met.
- 3. The review is the first opportunity that local residents, businesses, existing licence holders and their representatives have had to formally comment on the Policy since 2015. The consultation exercise begins on the 3rd of April and finishes on the 1st of June 2018.

Functions of Licensing Authorities

- 4. The Act gives licensing authorities a number of important regulatory functions in relation to gambling. Their main functions are to:
 - Licence premises for gambling activities;
 - Consider notices given for the temporary use of premises for gambling;
 - Grant permits for gaming and gaming machines in clubs and miners' welfare institutes;
 - Regulate gaming and gaming machines in alcohol licensed premises;
 - Grant permits to family entertainment centres for the use of certain lower stake gaming machines;
 - Grant permits for prize gaming;
 - Consider occasional use notices for betting at tracks; and
 - Register small societies' lotteries.

Premises licences

- 5. Premises licences will be granted by licensing authorities and may authorise the provision of facilities on:
 - Casino premises;
 - · Bingo premises;
 - Betting premises, including tracks;
 - Adult gaming centres; and
 - Family entertainment centres.
- 6. Except in the case of tracks (where the occupier of the track who gets the premises licence may not be the person who actually offers the gambling) premises licences may only be issued to people with a relevant gambling operators licence: for example, to obtain a bingo premises licence, the applicant must hold a bingo operating licence. Premises licences are transferable to someone else holding a valid operating licence.
- 7. In exercising most of their functions under the Gambling Act 2005, licensing authorities must have regard to the licensing objectives as set out in Section 1 of the Act. The licensing objectives are:
 - Preventing gambling from being a source of crime or disorder, being associated with crime or disorder or being used to support crime;
 - Ensuring that gambling is conducted in a fair and open way;
 - Protecting children and other vulnerable persons from being harmed or exploited by gambling.
- 8. The Gambling Commission will be responsible for granting operating and personal licences for commercial gambling operators and personnel working in the industry. It will also regulate certain lottery managers and promoters.
- This consultation paper is aimed at local residents, businesses, existing licence holders and their representatives. Indeed the Council is anxious to receive the views of all interested parties.
- 10. The Council has identified people and organisations that may be interested in responding to this consultation. However, the Council would welcome the views of any interested parties and recipients should feel free to draw the attention of this paper to others who might be interested in responding to the consultation.
- 11. In order to comment in detail on the gambling policy, respondents may first wish to refer to the guidance issued under the Act to local authorities by the Gambling commission as well as the current Gambling Policy and the Gambling Act itself. Introduction

- 1. When the current policy was adopted by the authority in February 2016, it was resolved that a further consultation would be undertaken regarding the possible adoption of a cumulative impact policy in respect of Lammas Street, Carmarthen.
- 2. This is an opportunity for local residents, businesses, existing licence holders and their representatives to formally comment on the proposal and provide feedback to the Authority.
- A plan showing Lammas Street, Carmarthen is attached as Annex A. Lammas
 Street is highlighted in red from it's junction with Dark Gate along the whole length
 of the street to it's junction with Morfa Lane. If adopted for this area the cumulative
 impact policy would include any premises which shares a boundary with Lammas
 Street.
 - The consultation commences on the 3rd of April 2018 and finishes on the 1st of June 2018
- 4. The following paragraphs have been reproduced from the guidance issued by the Home Office under section 182 of the Licensing Act 2003.

What is Cumulative Impact?

14.20 "Cumulative impact" is not mentioned specifically in the 2003 Act. In this Guidance, it means the potential impact on the promotion of the licensing objectives of a significant number of licensed premises concentrated in one area. The cumulative impact of licensed premises on the promotion of the licensing objectives is a proper matter for a licensing authority to consider in developing its licensing policy statement. Cumulative impact policies (CIP) may relate to premises licensed to carry on any licensable activity, including the sale of alcohol for consumption on or off the premises, and the provision of late night refreshment. This includes late night fast food outlets which are not licensed to sell alcohol.

Effect of Special Policies

14.30 The effect of adopting a special policy of this kind is to create a rebuttable presumption that applications for the grant or variation of premises licences or club

premises certificates which are likely to add to the existing cumulative impact will normally be refused or subject to certain limitations, following relevant representations, unless the applicant can demonstrate in the operating schedule that there will be no negative cumulative impact on one or more of the licensing objectives. Applicants should give consideration to potential cumulative impact issues when setting out the steps they will take to promote the licensing objectives in their application.

- 14.31 However, a special policy must stress that this presumption does not relieve responsible authorities (or any other persons) of the need to make a relevant representation, referring to information which had been before the licensing authority when it developed its statement of licensing policy, before a licensing authority may lawfully consider giving effect to its special policy. If there are no representations, the licensing authority must grant the application in terms that are consistent with the operating schedule submitted.
- 14.32 Once adopted, special policies should be reviewed regularly to assess whether they are needed any longer or if those which are contained in the statement of licensing policy should be amended.
- 14.33 The absence of a special policy does not prevent any responsible authority or other person making representations on an application for the grant or variation of a licence on the grounds that the premises will give rise to a negative cumulative impact on one or more of the licensing objectives.
- 14.34 Special policies may apply to the impact of a concentration of any licensed premises, including those licensed for the sale of alcohol on or off the premises, and premises licensed to provide late night refreshment. When establishing its evidence base for introducing a special policy, licensing authorities should be considering the contribution to cumulative impact made by different types of premises within its area, in order to determine the appropriateness of including different types of licensed premises within the special policy.

If adopted, a cumulative impact policy would form part of the authority's Licensing Policy.

- 5. The Licensing Policy has four main purposes, these are:
 - To reinforce to elected members on the licensing committee, the boundaries and power of the local authority, and to provide them with parameters under which to make their decisions. The committee will be able to test the application against criteria set out in the policy and if necessary add conditions to those set out in the operating schedule.
 - To inform the licence applicants of the parameters under which the authority will
 make licence decisions, set out examples of good management practice and
 therefore how a licensed premises is likely to be able to operate within an area.
 (Note however that each case must be examined on an individual basis).
 - To inform residents and businesses of the parameters under which the authority will make licence decisions, and therefore how their needs will be addressed.
 - To inform a court of law how the council arrived at its decisions when these are challenged in a court, and to support these decisions.



The Assistant Solicitor briefed all present on the procedure for the meeting and advised the Sub Committee that an application had been received for the grant of a Premises Licence in respect of Etto's Coffee Shop, 25 High Street, Llandybie, SA18 3HX to permit:-

Supply Of Alcohol Sunday to Thursday 12:00 – 22:00

Friday and Saturday 12:00 - 23:00

Opening Hours Sunday to Thursday 07:00 – 22:30

Friday and Saturday 07:00 – 23:30

The Sub-Committee noted that the following documentation was attached to the report:

- Appendix A Copy of the application
- Appendix B Representations submitted by the Licensing Authority
- Appendix C Representations submitted by the Dyfed Powys Police
- Appendix D Representations submitted by other persons

In addition to the above, the Sub-Committee received, with the consent of all parties, the following additional documentation:

- Plan detailing the location of the premises
- Correspondence from the Dyfed Powys Police withdrawing its objections following agreement having been reached with the applicant on the



- inclusion of its suggested 18 conditions to be applied to the Licence, if granted.
- Correspondence dated 17th February from the applicant accepting the Police's suggested 18 conditions.

The Licensing Authority Representative referred to his written representations, as detailed within Appendix B to the report, and confirmed that subsequent thereto the Licensing Authority had been advised by the Dyfed Powys Police that it was withdrawing its representations on the basis agreement had been reached with the applicant on the inclusion of its suggested 18 conditions to the Licence. As a result of that agreement, he suggested that should the Sub Committee be minded to grant the application, as submitted, those 18 conditions replace the conditions attached to the original operating schedule.

The Licensing Authority Representative also referred to Appendix D to the report and to the comments received from the Llandybie Community Council to the effect that whilst supporting the application, it was of the view the sale of alcohol should be restricted until after 6.00 p.m. when there was less of a likeliehood of unaccompanied children being present when alcohol was sold. In light of that representation, the Licensing Authority had considered the provisions of Paragraph 91 of the Council's Licensing Policy and parts 14.46 and 14.49 of Statutory Guidance relating to access by children to licensed premises, and was of the view there was no requirement for additional conditions to be applied to the Licence.

All parties present were afforded the opportunity of questioning the Licensing Authority representative on his submission.

A representation was received in support of the application citing the excellent manner in the way the business currently operated which had provided both jobs and increased footfall within the village of Llandybie. The concerns of Llandybie Community Council were not supported.

All parties present were afforded the opportunity of questioning the supporter on his submission.

The applicant outlined to the Sub-Committee his reasons for seeking a premises licence for the purposes of enabling customers to enjoy an alcoholic drink with afternoon teas/ evening snacks etc in a coffee house environment. The premises currently operated as a coffee house catering for a wide clientele base which included families with children. As that custom was highly valued, he would not wish to jeopardise that by changing the business emphasis to another drinking establishment. In that regard, he would not tolerate any unruly behaviour and could consider raising alcohol prices to prevent such a position developing.

All parties present were afforded the opportunity of questioning the applicant on his on his submission.

UNANIMOUSLY RESOLVED to retire into private session in order to receive legal advice pursuant to Paragraph 16 of Schedule 12 to the Local Government Act.



Following the adjournment, the Sub Committee reconvened to advise of its decision and, having regard to the relevant paragraphs of the Licensing Authority's Statement of Licensing Policy and the guidance issued by the DCMS and the Home Office, it was

RESOLVED that the application for a Premises Licence for Etto's Coffee shop, 25 High Street, Llandybie for the sale of alcohol during the requested hours be granted subject to the licence conditions agreed between the applicant, Licensing Authority and the Dyfed Powys Police being attached to the licence.

REASONS

In coming to its decision, the Sub-Committee made the following findings of fact;

- 1. The premises had not previously been licensed under the 2003 Act
- 2. There was no history of licensing enforcement action relating to the premises
- 3. None of the responsible authorities opposed the granting of a licence for the sale of alcohol, subject to the conditions agreed with the applicant
- 4. That only one objection had been received regarding opening hours and there was no evidence submitted to require such a restriction

The applicant thereupon addressed the concerns and issues raised and stated that in light of the concerns of nearby businesses and property owners she was withdrawing her application for Mondays, Tuesdays and Wednesdays and would look to open on these days on a seasonal basis only.

All parties were afforded the opportunity of questioning the evidence submitted.

The Sub-Committee thereupon

UNANIMOUSLY RESOLVED to retire into private session in order to receive legal advice pursuant to Paragraph 16 of Schedule 12A of the Local Government Act.

Following the adjournment, the Sub-Committee reconvened to advise of its decision and, having had regard to relevant paragraphs of the Licensing Authority's Statement of Licensing Policy and the guidance issued by the DCMS and the Home Office, it was

RESOLVED, having considered the evidence placed before the Sub Committee, that the application be granted, subject to the additional licence conditions agreed between the applicant and the responsible authorities.

REASONS:-

In coming to its decision, the Sub Committee made the following findings of fact;

- The Premises had previously had the benefit of a Premises Licence from 2005 until September 2017. No enforcement action had been taken by the licensing authority, nor were any complaints or referrals received during this period.
- 2. Public Health services had no recent records of complaints regarding the premises when it had previously been licenced.

- 3. None of the responsible authorities objected in principle to the granting of the licence
- 4. No representations had been received from the Fire authority
- 5. There was a past history of crime and disorder and public nuisance at, associated with, and in the vicinity, of the premises both whilst previously licenced and since September 2017.
- 6. The premises was located in a narrow lane in close proximity to residential and commercial premises
- 7. The premises was in the vicinity of Queen Street and King Street Carmarthen, both of which were identified in the statement of Licensing Policy as crime and disorder 'hotspots'
- 8. The applicant accepted the control measures proposed by the Police as amended.
- 9. The applicant and Responsible authorities had agreed a set of 'potential conditions' as amended designed to prevent public nuisance.
- 10. The applicant wished to withdraw her application for Mondays, Tuesdays and Wednesdays.
- 11. There was no application for regulated entertainment.

In the absence of any representations from the Fire Authority the Sub Committee had not considered any issues of Fire Safety.

The Sub Committee took into account issues of the Crime and disorder in the vicinity of the premises but not attributable to it.

The Sub Committee recognised that its decision had to be based upon real evidence, and that concerns and fears about what might happen if a licence were granted, where unsupported by such evidence, were not matters which they could properly take into account.

The Sub Committee found the evidence of the local residents to be credible and compelling and accepted that what they said was real evidence of crime and disorder and public nuisance associated with and in the vicinity of the premises.

The Sub Committee had attached weight to the views of the responsible authorities as it was legally obliged to do so. The Sub Committee dld not believe that the evidence presented was sufficient to justify the Sub Committee departing from its views.

On the basis of the evidence put before it the Sub Committee was satisfied that to grant the application subject to the amended conditions agreed between the applicants and the responsible authorities would not undermine the licensing objectives of preventing crime and disorder and preventing public nuisance.

The Sub Committee believed that these conditions were appropriate to promote the Licensing Objectives and a proportionate response to the problems identified. In light of the views of the responsible authorities the Sub Committee did not believe that it would be appropriate or proportionate to refuse the application outright.

There were no declarations of personal interest.

3. MR UMAAR BIN HAMEED - HACKNEY CARRIAGE/PRIVATE HIRE DUAL DRIVERS LICENCE

The Committee was informed that Mr Umaar Bin Hameed of Flat 2, 27 Picton Terrace, Carmarthen was a licensed Hackney Carriage/Private Hire Dual Driver with the authority and that an issue had arisen with regard his licence. The Committee noted that Mr Hameed was not in attendance at today's meeting, he had not contacted officers to offer an explanation and he had been advised that, should he fail to attend today's meeting, his application may be considered in his absence. In addition, the Committee noted that the complainant was in attendance. It was therefore:

RESOLVED that the Committee consider the issue raised in Mr Hameed absence.

The Senior Licensing Officer recited, to the Committee, 3 witness statements. The Committee interviewed the complainant with regard to the issue.

The Senior Licensing Officer recommended that Mr Hameed's Hackney Carriage/Private Hire Dual Drivers' Licence be suspended for 14 days.



The Committee thereupon:

RESOLVED to retire into private session in order to receive legal advice pursuant to Paragraph 16 of Schedule 12A of the Local Government Act 1972.

Following the adjournment the Committee reconvened to advise of its decision.

RESOLVED that, in line with the Council's guidelines, Mr Ummar Bin Hameed Hackney Carriage/Private Hire Dual Driver's Licence be suspended for 14 days.

Reasons

The Committee, having regard to the evidence presented, believed that reasonable cause existed to due to the following reasons:

- The Committee finds the evidence of the complainant to be credible and compelling.
- Mr Hameed failed to attend
- Whilst the Committee accepts that Mr Hameed did not overtly refuse to take the complainant and her guide dog, it believes that he did fail to take them without reasonable cause.
- The Committee is satisfied that this amounts to a reasonable cause to suspend Mr Hameed's Hackney Carriage/Private Hire Dual Driver's Licence.

4. MR EIRWYN LYN DAVIES - HACKNEY CARRIAGE/PRIVATE HIRE DUAL DRIVERS LICENCE

The Committee was informed that Mr Eirwyn Lyn Davies of Bro Helyg, Pontardulais Road, Tycroes, Ammanford was a licensed Hackney Carriage/Private Hire Dual Driver with the authority and that an issue had arisen with regard his licence.

The Committee interviewed Mr Davies with regard to that issue.

The Senior Licensing Officer recommended that Mr Davies be issued with a final warning as to his future conduct.

RESOLVED that in line with the Council's guidelines Mr Eirwyn Lyn Davies be issued with a final warning as to his future conduct.

5. MR RUSSELL ALAN HOWE - HACKNEY CARRIAGE/PRIVATE HIRE DUAL DRIVERS LICENCE

The Committee was reminded that consideration of this application was deferred at the meeting held on 19th February 2018 as Mr Howe was unable to attend.

The Committee was informed that Mr Russell Alan Howe of 28 Park Hall, Carmarthen was a licensed Hackney Carriage/Private Hire Dual Driver with the authority and that an issue had arisen with regard his licence.



The Committee interviewed Mr Howe with regard to that issue.

The Senior Licensing Officer recommended that Mr Howe be issued with a warning as to his future conduct.

The Committee thereupon:

RESOLVED to retire into private session in order to receive legal advice pursuant to Paragraph 16 of Schedule 12A of the Local Government Act 1972.

Following the adjournment the Committee reconvened to advise of its decision.

RESOLVED that in line with the Council's guidelines Mr Russell Alan Howe be issued with a warning as to his future conduct.

6. MR DAVID GEORGE HOPKINS - APPLICATION FOR THE GRANT OF A HACKNEY CARRIAGE/PRIVATE HIRE DUAL DRIVERS LICENCE

The Committee considered an application from Mr David George Hopkins of 4 Dolau Bran, Llandovery for the grant of a hackney carriage/private hire dual drivers licence.

The Committee interviewed Mr Hopkins with regard to his application. In addition, the Senior Licensing Officer recited, to the Committee, 3 character references.

The Senior Licensing Officer recommended that Mr Hopkins' application be refused.

The Committee thereupon:

RESOLVED to retire into private session in order to receive legal advice pursuant to Paragraph 16 of Schedule 12A of the Local Government Act 1972.

Following the adjournment the Committee reconvened to advise of its decision.

RESOLVED that in line with the Council's guidelines, the application submitted by Mr David George Hopkins for the grant of a Hackney Carriage/Private Hire Dual Driver's Licence be granted with a warning as to his future conduct.

Reasons

On the evidence presented the Committee was satisfied that the applicant was a fit and proper person to hold a licence.



7. LICENSING ACT 2003 - FILM CLASSIFICATION REQUEST

The Committee considered a report outlining a request that had been received from Mrs Mair Craig on behalf of Llansadwrn Reading Rooms seeking a recommendation regarding the admission of children to view two previously unclassified short films.

The applicant intended to screen two Welsh language films, "Sampli" and "Helfa'r Heli" prior to the screening of a certificated feature film at the community cinema. Furthermore, the premises intended operating the community cinema under the community premises exemptions set out in paragraph 6A of Schedule 1 of the Licensing Act 2003.

The Committee noted that in order to satisfy the requirements of the Licensing Act 2003, the films shown must have a recommendation concerning the admission of children issued by either the British Board of Film Classification (BBFC) body or relevant Licensing Authority.

In order that the Committee make the required recommendation regarding the admission of children to view the films, the Committee was afforded the opportunity of watching the two short films and took into consideration the references to imitable behaviour, language, nudity and sex.

The Committee was presented with a written representations regarding the two films from the applicant.

The Committee gave due regard to relevant paragraphs of the Licensing Authority's Statement of Licensing policy and of Guidance issued by the British Board of Film Classification appended to the report in Appendix 1.

Having considered all the evidence before it, the committee thereupon

RESOLVED that:

- 1. the film entitled "Sampli" should be classified with the rating PG
- 2. the film entitled "Helfa'r Heli" should be classified with the rating 12A

Reasons

In coming to its decision, the Committee made the following findings of fact;

- Neither film has previously been classified by either the BBFC or another local authority.
- That the content of the film entitled "Sampli" meets the BBFC criteria for a PG rating.
- That the content of the film entitled "Helfa'r Heli" meets the BBFC criteria for a 12A rating.



Having regard to the contents of the both films, representations received from the applicant and guidance issued by the BBFC the Committee is satisfied that it is necessary to classify both films as shown above in order to promote the Licensing Objective of protecting children from harm.

The Committee is satisfied that this is a proportionate response to the specific content of each film.

8. TO SIGN AS A CORRECT RECORD THE MINUTES OF THE MEETING OF THE LICENSING COMMITTEE HELD ON THE 19TH FEBRUARY, 2018.
