1. DECLARATION OF PERSONAL INTEREST

There were no declarations of personal interest.

2. CARMARTHEN SHOPMOBILITY

The Executive Board Member considered a report to support Carmarthen Shopmobility with a further grant of £14,650 for a twelve month period commencing in September 2018. It was explained that Shopmobility was one of the key priorities within the Council's Integrated Parking Strategy and had been supported by the Council since 2011, with the current funding arrangements due to expire this year. It was noted that whilst the Group generated income from charges and fund raising, it was mainly reliant on the Council's financial support.

RESOLVED that Carmarthen Shopmobility be supported with a further grant of £14,650 for a further twelve month period commencing in September, 2018, subject to the conditions detailed in the report.

3. LLANELLI SHOPMOBILITY

The Executive Board Member considered a report to support Llanelli Shopmobility with a further grant of £14,650 for the 2018/19 financial year commencing on 31st July, 2018. It was highlighted that Shopmobility was one of the key priorities within the Council's Integrated Parking Strategy and had been supported by the Council since 2011, with the current funding arrangements due to expire this year. It was noted that whilst the Group generated income from charges and fund raising, it was mainly reliant on the Council's financial support.

RESOLVED that Llanelli Shopmobility be supported with a further grant of $\pm 14,650$ for the 2018/19 financial year commencing on the 31^{st} July, 2018.

4. PROPOSED TRAFFIC CALMING - GARREGLWYD, PEMBREY

The Executive Board Member considered a report on proposals by the Authority, following a request received from Persimmon Homes, for the introduction of a Priority Give Way System at Garreglwyd Pembrey due to the narrow width of the existing public highway from the main A484 to the Garreglwyd Housing Estate where there was insufficient width to accommodate both footways for pedestrians and maintain two-way traffic flow for vehicles. The proposal, if adopted, would

facilitate the safe traffic flow through the narrow road with priority afforded to northbound travelling vehicles to protect the Strategic Highway Network the cost of which would be borne by the developer under a Section 278 Agreement.

It was reported that following publication of the proposal, no objections had been received from the statutory consultees. However, 10 written objections had been received, which were detailed within the report together with the officer responses.

RESOLVED that the objections received to the proposed Priority Give Way System at Garreglwyd, Pembrey be noted, but that the Order be introduced in the interests of general road safety to facilitate the provision of a safe footway link for pedestrians from the main A484 to the Garreglwyd estate and to manage the safe flow of traffic through the narrowing of the Highway.

EXECUTIVE SUMMARY

EXECUTIVE BOARD MEMBER DECISIONS MEETING FOR ENVIRONMENT

23 JANUARY 2019

Objections to the County of Carmarthenshire - Waiting Restrictions and Street Parking -(Llanelli) (Variation 33)

1. Purpose

1.1 This report is to determine objections received to the proposed on-street waiting restrictions. Full details of the proposed restrictions are listed in **Appendix 1** and **Appendix 2** of the report. The purpose of the proposed restrictions is to safe guard road users and to facilitate the safe and unhindered passage of traffic.

2. Consultation

2.1 The advertised proposals are listed in **Appendix 1**.

3. Objections and comments:

3.1 During the consultation period the Council's Head of Administration and Law received eight objections and a petition against the advertised proposals. These objections are summarised in Appendix 3 along with officer comments and recommendations.

3.2 In brief , the objections are explained below : -

3.2.1 **Mount Pleasant Buildings** - Extend existing prohibition of waiting restrictions (double Yellow lines) by a short distance on one side to prevent vehicles being parked in the flow of traffic

3.2.1.1 The objectors are concerned that the intended double Yellow lines will reduce the provision of on – street parking spaces available to local residents.

3.2.1.2 Recommendation :

Implement the proposals as described in Appendix 1.

3.2.2 **Erw Road** - Introduce no loading/ unloading restrictions to address dangerous parking on the nearside pavement adjacent to Avenue Villa surgery.

3.2.2.1 The objector is concerned that the intended no loading / loading restrictions will reduce the provision of on street parking spaces available to those who opt to park their vehicles(with a valid Blue badge on display) on the existing double Yellow lines in the vicinity of the surgery and nearby junctions.

3.2.2.2 Recommendation:

Implement the proposals as described in Appendix1.

3.2.3 **Brynamlwg** - Extend prohibition of waiting restrictions (double Yellow lines) on the junction to facilitate the unhindered movement of municipal vehicles.

3.2.3.1 The objectors are concerned that the intended waiting restrictions (double Yellow lines) will reduce the provision of on street parking spaces available to local residents.

3.2.3.2 Recommendation: Amend the advertised proposals as follows:

Extension to prohibition of waiting at any time

Street: Bryn amlwg,Llanelli

South side - From a point 23 metres North East of its junction with Frondeg Terrace for a distance of 35 metres in a South Westerly direction.

3.2.4 Lane between Pembrey Road and the lane to the rear of Greenway street-remove double Yellow lines

3.2.4.1The objector is concerned that vehicles will be parked in the flow of traffic

Recommendation: Amend the advertised proposals as follows:

Revocation of prohibition of waiting at any time

Street - Lane to rear of Pembrey Road, Llanelli

East side-From a point 5 metres North West of its junction with the rear lane of Greenway street for a distance of 9 metres in a North Westerly direction.

PUBLIC NOTICE

THE COUNTY OF CARMARTHENSHIRE (LLANELLI) (WAITING RESTRICTION AND STREET PARKING PLACES) CONSOLIDATION (VARIATION NO 33) ORDER 2017

NOTICE is hereby given that the Carmarthenshire County Council propose to make an Order under Sections 1 (1), 2(1) to (3), 4(2), and 1 2 4 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") as amended and Traffic Management Act 2004.

The effect of the Order will be to amend The County of Carmarthenshire (Llanelli) (Waiting restrictions and Street Parking Places) Consolidation Order 2004 ("The Consolidation Order") (which provides for decriminalised enforcement of contraventions of waiting prohibitions and restrictions) by substituting the plans annexed thereto with the corresponding number plans annex to the order.

The consequence of the proposed amendment will be to:

- 1. Prohibit Waiting at any Time in the lengths of road and on the sides of road specified in Schedule 1 to this Notice.
- 2. Extend the Prohibition of Waiting at any Time in the lengths of road and on the sides of road specified in Schedule 2 to this Notice.
- 3. Revoke the existing Prohibition of Waiting at any Time on the lengths and side of road specified in Schedule 3 to this Notice.
- 4. Prohibit Loading and Unloading at any Time on the lengths and side of road specified in Schedule 4 to this Notice.
- 5. Prohibition of Waiting, Loading and Unloading at any Time on the lengths and side of road specified in Schedule 5 to this Notice.
- 6. Proposed Loading Only Monday to Saturday, 8 a.m to 6 p.m 30 minutes no return within 1 hour on the lengths and side of road specified in Schedule 6 to this Notice.
- 7. Limited Waiting Monday to Saturday, 8 a.m to 6 p.m 30 minutes, no return within 1 hour on the lengths and side of road specified in Schedule 7 to this Notice.
- 8. No Stopping Except for Taxis replaced with 1 hour Limited Waiting, Monday to Saturday, 8 a.m to 6 p.m, No return within 2 hours on the lengths and side of road specified in Schedule 8 to this Notice.
- 9. Proposed Limited Waiting, Monday to Saturday, 8am to 6p.m, No return within 1 hour on the lengths and side of road specified in Schedule 9 to this Notice.
- 10.Proposed Revocation of Prohibition of Waiting at Any Time on the lengths and side of road specified in Schedule 10 to this Notice.
- 11. The County of Carmarthenshire (Llanelli) Variation No. 25, Order 2014, will be revoked in so far as it relates to the sides of roads specified in the Schedule of this Order.

and will replace the existing prohibitions and restrictions (if any) that affect the parts of the roads specified in the Schedule to this Notice.

The provisions for the usual exemptions contained in the Consolidation Order will apply in relation to the lengths of road and sides of road referred to in paragraph 1 and 2 above. These include the right for passengers to board and alight from a vehicle, for the loading and unloading of goods, for the carrying out of building operations and other works, for the performance of statutory powers or duties, and to enable a vehicle to take in petrol, oil, water or air from any garage situated adjacent to such parts of the roads affected by the proposed restriction.

The Consolidation Order contains the usual parking concessions (where appropriate) for disabled persons in accordance with the Blue Badge Scheme.

Full details of these proposals are contained in the draft Order which, together with the plans annexed thereto showing the lengths of road affected and a statement of the Council's reason for proposing to make the Order, may be inspected at the offices of the

Council's Customer Service Centre at The Hub, Stepney Street, Llanelli during the usual office hours.

If you wish to object to the proposed Order you should send the grounds for your objection in writing to The Head of Administration and Law by Friday the 3rd of March, 2017.
