Event Support Fund Applications July 2019

1. BRIEF SUMMARY OF PURPOSE OF REPORT

As part of a series of actions to grow the contribution of events and festivals in Carmarthenshire, £20,000.00 has been approved to provide an event support fund scheme aimed at providing financial assistance to events in the county that can demonstrate that they can make a contribution to the Tourism, Community and Economic strategic aims. As of 24th June 2019, £16,872.00 has already been committed from the 19/20 fund

The following applications has been received and assessed against the criteria with the following recommendation;

- Bosworth Day Event, Carmarthen 2019: Recommended support £350.00
- Llanelli Pride 2019: Recommended support £700.00
- Sioe CFFI Llanllwni YFC Show 2019: Recommended support £520.00

Total amount recommended £1,570.00

2. OTHER OPTIONS AVAILABLE AND THEIR PROS AND CONS

With the scheme in past years oversubscribed in terms of requests v funds total, there is the option to keep some funds in reserve for the possibility of receiving higher scoring applications between now and the end of the financial year in March 2020. It would also be effective to support the potential plans forthcoming from the village and town of culture 2019.

Each event organiser will receive specific criteria evidence and items to be supported within their respective offer letters allowing for greater clarity on the impact of the council support

Background

Synrgy Room and Spin rooms offer a great product to members and pay as you go customers. There is an opportunity out of core hours to hire these spaces to clubs and groups for private hire.

This would be a method by which income could be grown from these activity areas within the business. Planned charges can be seen below.

Recommendations:

These charges are the current maximum tariff, any reduction has to be authorised by the Facility Manager and authorised by either the Senior Actif Operations Manager or Senior Sport & Leisure Manager

Group Hire Spin Studios

- Exclusive Hire £50 per session virtual classes
- Exclusive Hire £70 per session with an instructor

Group Hire Synrgy (note slight increase in rate)

• Exclusive Hire £55 per session with an instructor (up to 15 participants)

(This replaces the original trial price of £50

Exclusive hires will increasingly be promoted as we progress through the summer months to capitalise on the indoor autumn/winter training seasons.

All sessions for members and pay as you go customers are currently being promoted aligned with the new spin studios at Amman Valley LC and Llanelli LC.
