



f) Proposed Operating Schedule.

Having considered the current application and the operating schedule put forward by the applicant, the Licensing Authority believes that, if the application were granted, the wording set out in the operating schedule, which refers to the existing licence conditions, is not sufficiently precise to enable it to form clear enforceable licence conditions in accordance with section 18(2)(a) of the Licensing Act .

The Dyfed Powys Police and Public Health Services have both submitted letters of representation in relation to the application. The Police representation requests that additional conditions be attached to the licence should the application be granted. The Public Health Services representation also outlines licence conditions which they believe are appropriate to attach to the licence if the application is granted. In addition they have outlined amendments to the application which have been discussed with the applicant and which have subsequently been agreed by the applicants legal representative.

A further representation has been received from a person representing local residents, which sets out their concerns regarding the application. The subcommittee will have to be satisfied that granting the application will not undermine the licensing objectives.

If the application is granted, I believe it would be appropriate to replace all the statements made in the operating schedule with conditions numbered 1-21, requested by the Police and conditions 1-6 requested by Public Health Services.

These representations have been prepared on the 21st of October 2015 with the benefit of viewing the original application and representations from the Police, Public Health Services and the representative of local residents.

With reference to the above application the Carmarthenshire Division of the Dyfed Powys Police will make the following representations.

- The whole of the licensed area with entry and exit areas must be covered by cameras, and there must not be any hidden or obscured areas. This will deal with issues which have arisen outside the premises when customers have been arriving or leaving.
- 2. Main entrance exit to have a camera meeting a minimum of 100%R image quality.
- 3. All footage must be of good quality and of a minimum performance capability sufficient to identify individuals.
- 4. It must be in colour.
- 5. It must record at a minimum of 12 images per second.
- 6. All images will be time and date stamped.
- 7. All footage during the hours of Licensable activities to be retained for a period of 30 days.
- 8. The CCTV system must operate continuously, and if a defect arises the police must be informed and immediate arrangements must be made to rectify the fault
- All footage must <u>on demand</u> be made available to a Police Officer, Police Community Support Officer and Local authority Officer for viewing and a copy of that footage made immediately available to the above officers.
- 10. At all times during the period of operation of the premises there must be a competent person on the premises capable of reply and be able to undertake the export of recordings quickly onto a removable storage medium. Memory Stick, CD, or DVD format is acceptable to the police. The master copy will be available to the police on demand.
- 11. The system must incorporate a means of transferring images from the hard-drive to a format that can be played back on any Microsoft Windows or MAC compatible computer. The application software required to launch and view recorded

images must either be included as part of the standard operating system installed or be installed to the recorded media when the data is copied to that media.

12. The system must be registered with the Information Commissioner (Tel 0303 123 1113 or email registration@ico.org.uk)

Please refer to the Dyfed Powys Police CCTV requirement document for full specification. This can be accessed by contacting Pc. Rob Chapman at the Community Safety Office Ammanford Police Station telephone number 01269 590580 as a matter of urgency to discuss the above CCTV conditions prior to any agreement being reached. To ensure that any system installed complies with the requirements of the proposed licence conditions.

- 13. No open glass or glass vessels to be removed from the boundary of the premises.
- 14. The DPS to become a member of the local Pub Watch scheme and to support the BOBB scheme, 'Behave or be Banned'.

As per paragraph 6.7 within the Licensing Policy

- 15. The challenge 21 scheme to be adopted at the premises with notices and posters to be clearly displayed in the premises, near the entrances and bar areas. To emphasise to customers that they will be challenged if they look 21 and under.
- 16. No person under the age of 18 shall be employed on the premises whether paid or unpaid for the purpose of serving alcohol.
- 17. No children under the age of 16 years to remain on the premises after 22:00 unless they are attending a pre-booked event or function and in the company of a parent or responsible adult.
- 18. The applicant to risk assess the use of door supervisors whenever Regulated Entertainment is provided after 11pm.

The applicant to also risk asses the use of door supervisors at all other times for Regulated Entertainment, if provided before 11pm. especially on Bank Holiday weekends, Christmas Eve, Boxing Day and New Year's Eve and major televised sporting events.

When employed Door Supervisors must be registered with the SIA, to be on duty until the time that all members of the public have left the premises.

The Licence Holder shall supply an appropriate number of Door Supervisors for the maximum occupancy figure stated in the licence and the appropriate number shall be 2 in respect of the first 100 persons and one for each additional 100 persons or part of 100 persons comprised in the maximum occupancy figure.

Door Supervisors shall not be permitted to consume intoxicating liquor or other Intoxicants during any period of duty at the Premises. A Door Supervisor shall report on duty in a sober condition.

The Designated Premises Supervisor or Premises Licence Holder shall nominate for each and every exit door a Door Supervisor who's duty it shall be to ensure that the exit door is opened immediately in the event of a Fire or other Emergency and if practicable no more than one door shall be designated to each Door Supervisor.

No Door Supervisors shall be engaged in any duty that would otherwise prevent him, carrying out his duty as a Door Supervisor or exercising general supervision and control of persons attending the Premises.

Door supervisors to remain on duty after Regulated Entertainment ends until permitted hours in respect of the supply of alcohol finishes.

As per paragraph 6.1 within the Licensing Policy.

- 19. Neighbour courtesy notices to be displayed at the premises.
- 20. The consumption of alcohol by customers at the premises must cease at or before the end of opening hours as specified in the premises licence. Staff are required to collect all alcoholic drinks prior to the end of the opening hours as set out in the licence.
- 21. That there is a terminal hour of 22.30 in any outside location within the boundaries of the premises, for the consumption of alcohol.

As per paragraph 6.4 within the Licensing Policy

The above conditions the police believe are necessary and appropriate to promote the Licensing Objectives.


Further to the receipt of the above application the Environmental Health Team of Carmarthenshire County Council make the following representations.

Subsequent to meeting with the applicant at the above premise the following points were discussed.

- The application would be amended to reduce the hours for regulated entertainment. Regulated Entertainment from Sunday to Thursday would finish at 12:30am, however Friday and Saturday would remain unchanged.
- The smoking area for customers would be at the front of the premises.
- The extraction system for the kitchen would be located on the facade facing the rear of 45 Quay Street, Ammanford.

Therefore based on the above the following conditions should be attached to the premises licence in order to ensure that the "Prevention of Public Nuisance" of the Licensing objectives is being promoted.

- 1. During periods of regulated entertainment all external windows and doors shall be kept closed, other than for access and egress to the premise.
- 2. The area to the front of the premise shall be designated as the smoking area and all customers shall use this area for smoking.
- 3. A suitable receptacle shall be provided in the smoking area for customers to dispose of their cigarette ends.

- 4. After 22:30 the consumption of alcohol shall not be permitted in any outside locations within the boundary of the premises.
- 5. Neighbour courtesy notices shall be displayed at the premises.
- 6. The extraction system for the kitchen of the premise shall be located on the facade facing the rear of 45 Quay Street, Ammanford. Any alterations on the location of the extraction system shall only be done through written approval from the Environmental Health and Licensing Section of Carmarthenshire County Council.

Should you agree with the above and wish to accept the conditions, you are required to confirm in writing that you do so. A copy of your acceptance should be forwarded to the Licensing Section and myself.

Accepting the above will enable me to withdraw the representation and the above requirements will become conditions of your premises licence.
