**Objection – TEN Llandysul Paddlers, Wilkes Head Square, Llandysul (28/10/2016 – 30/10/2016)**

In relation to the application for a Temporary Event Notice (TEN) at the Llandysul Paddlers site in October I would like to raise an objection on behalf of the Public Health Section on the grounds of potential noise nuisance. The applicant is proposing regulated entertainment until 03:00 a.m on the 28<sup>th</sup> and 29<sup>th</sup> October 2016 and the likely low background noise levels at this location in the early hours of the morning, coupled with the music at the event is highly likely to give rise to noise complaints. Historically the event has given rise to complaints from the Ceredigion County Council Authority area when the event was previously operating until 03:00a.m. The music is also taking place in a marquee which provides very little in the way of noise attenuation.

In terms of mitigation I would propose that the applicant consider a finish of 01:00 or 01:30 at the latest to minimise the intrusion to residents living in the area.
