#### 1. APOLOGIES FOR ABSENCE

There were no apologies for absence.

2. DECLARATIONS OF PERSONAL INTEREST There were no declarations of personal interest.

#### 3. MINUTES RESOLVED that the minutes of the meeting of the Committee held on the 3<sup>rd</sup> June 2016 be signed as a correct record.

## 4. CODE OF CONDUCT TRAINING FOR TOWN AND COMMUNITY COUNCILLORS

Further to minute 12 of the meeting held on the 11<sup>th</sup> March 2016 the Committee received a report on the Code of Conduct training sessions held in June for representatives of local Town and Community Councils. The sessions had been well attended and feedback overwhelmingly positive with delegates being particularly appreciative of the guidance booklet on personal and prejudicial interests.

**UNANIMOUSLY RESOLVED** that the report be noted.

## 5. CODE OF CONDUCT COMPLIANCE BY TOWN AND COMMUNITY COUNCILLORS

The Committee, in accordance with its role in monitoring Code of Conduct compliance by Town and Community Councillors, received a report detailing the levels of code training received, declarations of interest made, dispensation requests granted and Code complaints registered in respect of Town and Community Councils within the County.

#### 6. REVIEW OF CORPORATE WHISTLEBLOWING POLICY

The Committee considered a report on the annual review of the Corporate Whistle Blowing Policy, with a view to incorporating relevant information thereon within the Chair's Annual Report to the Council. It was noted that the Council had continued to take steps to raise staff awareness of the policy and ensure managers were fully trained to recognise whistle blowing complaints and deal with them properly. The corporate Whistle blowing Policy had been updated to reflect organisational changes and feedback from the elected members briefing session earlier in the year.

The following observations/issues were raised on the report:-

- The Acting Legal Services Manager, in response to comment, stated that he had stressed to officers the need to keep staff apprised of developments in terms of their complaints subject to restrictions regarding personal information;
- The Acting Legal Services Manager agreed to follow up a concern relating to the appropriateness of including Whistleblowing case study 3, particularly if it was an actual case, given the outcome which indicated that 'the Council would be keeping a watchful eye over the home....'

#### **RESOLVED** that the report be received and the revised policy approved.

#### 7. PUBLIC SERVICES OMBUDSMAN FOR WALES REPORT 2015/16

The Committee considered the Annual Report of the Public Services Ombudsman for Wales for the period 2015/16 which contained details of complaints of maladministration and service failure against public bodies and allegations against members of Local Authorities that they had broken the Code of Conduct.

Overall the number of maladministration complaints against public authorities had risen by 4% compared to a 7% increase the previous year. Complaints against local authorities had fallen slightly from 938 to 906, the overall rise in complaints being due to a further increase in complaints against the NHS. Only 1 Public Interest Report had been issued against a local authority during this period and this had not related to Carmarthenshire County Council. The number of maladministration complaints against Carmarthenshire County Council had fallen by 57% to 40 in 2015/2016. This compared well with the Welsh average of 53 complaints. There had been a 19% increase in Code of Conduct complaints compared with last year, largely due to a 49% increase in complaints had been made against elected members of Carmarthenshire County Council although some of these had related primarily to the member's role as a Town and Community Councillor.

#### **RESOLVED** that the report be received.

#### 8. COMPLAINTS AND COMPLIMENTS

The Committee considered the End of Year Complaints and Compliments report which provided an analysis of the complaints and compliments received by the Authority during 2015/16.

It was reported that the authority had received 501 complaints during 2015/2016, compared to 573 in 2014/2015. This represented a continuing trend which had seen the number of complaints reduce from 727 in 2012/2013. A total of 463 complaints had been responded to during the year, including a number carried over from the previous municipal year. The number of cases responded to within

the required time period had fallen from 66% to 62%, reversing the previous trend. Owing to significant departmental re-organisations during the relevant period it had been difficult to make direct comparisons with previous years. However the new Environment Department (which included planning and waste services) continued to account for the majority of complaints, followed by the new Communities Department, which would also be responsible for a proportion of the Statutory Complaints referred to in the report. The number of compliments received had fallen slightly from 545 to 542 with the Communities and Environment Departments accounting for 78% of the compliments received.

The Committee was advised that subsequent to the above, an application had been submitted by Councillor Llewellyn seeking the renewal of his dispensation.

The Committee thereupon considered the renewal application submitted by Councillor Llewellyn, a member of the Llandybie Community Council, for the grant of a dispensation under the provisions of the Standards Committees (Grant of Dispensations) (Wales) Regulations to speak and vote at meetings of Llandybie Community Council in relation to the proposed transfer of County Council Assets to the Community Council.

It was reported that a dispensation was sought as Councillor Llewellyn had a personal interest in the matter by virtue of paragraph 10(2)(ii) of the Code of Conduct in that it related to or was likely to affect his employer, namely Carmarthenshire County Council.

Councillor Llewellyn's interest was also prejudicial as a member of the public with full knowledge of the facts could reasonably regard that interest as being so significant as to prejudice his judgement of the public interest.

Councillor Llewellyn had accordingly requested that a dispensation be granted under regulation 2 (d) of the Standards Committees (Grant of Dispensations) (Wales) Regulations on the basis his participation in any debate at meetings of the Community Council would not damage public confidence.

Following a detailed discussion it was

UNANIMOUSLY RESOLVED that dispensation be granted under Regulations 2(d) of the Standards Committees (Grant of Dispensations) (Wales) Regulations to Councillor I.R. #### APPLICATION FOR DISPENSATION BY COUNCILLOR SHAHID HUSSAIN

An application for dispensation to speak, vote and make written representations has been received from Councillor Shahid Hussain of Cwmamman Town Council in relation to the re-location of the village post office in Cwmamman to premises in which Councillor Hussain has a business interest.

Councillor Hussain has a personal interest in this matter by virtue of the following paragraphs of the Code of Conduct;

- 1. 10(2)(a)(i) as the matter relates to or is likely to affect a business carried on by him.
- 2. 10(2)(a)(ix)(bb) as the matter relates to or is likely to affect a company in which he holds a position of general control or management
- 3. 10(2)(b)(i) as the matter might reasonably be regarded as affecting his wellbeing

This interest is also a prejudicial interest as a member of the public, with full knowledge of the facts, would reasonably regard that interest as so significant as to prejudice the Councillor's judgement of the public interest.

The application is submitted on 1 grounds specified in the Standards Committees (Grant of Dispensation)(Wales) Regulations 2001 namely;

(f) participation justified due to the member's particular role or expertise

Cllr Hussain has previously been granted dispensation to speak only in respect of this interest on the 11<sup>th</sup> September 2015. This dispensation expired on the 4<sup>th</sup> December 2015.

I was granted dispensation last year for the same issue, I thought the matter was closed so did not renew or use the dispensation at the time. However, the matter has now come back up and I wish to talk about it and give an expert opinion

Having gone through the network transformation process on another of my sites 2.5 years ago. I am well placed to know what the process is , what risks are involved and what timescale/costs etc will be. Having been a Postmaster for 5 years on another site also, I am well versed in what the customer needs and requires from a Post Office and how their needs can be met. The other councillors do not have this expertise and background, and therefore I feel they will be making uninformed choices/decisions.

Having already been verified and chosen by Post Office Ltd to have the Post office relocate to my premises, this is not about making a decision, But only to clarify matters. Therefore the decision per se of the Council is irrelevant, so my contributing to the discussion will have no impact on the outcome. Therefore I feel I should be allowed to speak.

I also feel the other councillors have a prejudicial interest, in this matter as they wanted to Post office relocated to Glanamman community Centre, which is run and operated by Cwmamman Town Council. Therefore, they would benefit financially from Post Office moving there. Therefore I feel they would negatively impact upon my suitability

#### APPLICATION FOR DISPENSATION BY COUNCILLOR PHILIP NIGEL THOMPSON

An application for dispensation to speak and make written representations has been received from Councillor Philip Nigel Thompson of Kidwelly Town Council in relation to his involvement with Ynghyd Community Interest Company (of which he is a director) and the Kidwelly Community Hub (of which he is a member of the management committee).

Councillor Thompson has a personal interest in this matter by virtue of the following paragraphs of the Code of Conduct;

- 1. 10(2)(a)(ix)(bb) as the matter relates to or is likely to affect a company in which he holds a position of general control or management
- 2. 10(2)(a)(ix)(ee) as the matter relates to or is likely to affect a private association in which he holds a position of general control or management

This interest is also a prejudicial interest as a member of the public, with full knowledge of the facts, would reasonably regard that interest as so significant as to prejudice the Councillor's judgement of the public interest.

The application is submitted on 4 grounds specified in the Standards Committees (Grant of Dispensation)(Wales) Regulations 2001 namely;

(d) participation would not damage public confidence

(f) participation justified due to the member's particular role or expertise

(g) the business is to be considered by an overview or scrutiny committee (this ground does not apply in these circumstances)

(h) the business relates to a voluntary organisation and the councillor has no other interest in that matter (the committee may only grant a dispensation to speak under this ground).

In respect of item 1, the application to be involved in the asset transfer of the town's conveniences to the extent of converting the existing accessible toilet into an adult changing place, I am the lead director in Ynghyd CIC on this project.

The matter potentially involves the conversion of the existing accessible toilet into an adult changing place by inclusion of an adult lifting hoist and an adult changing table. The toilet is currently tension in the subject asset transfer County Council to the town council. Ynghyd CIC has acquired the necessary equipment, and would like to make it available to the general public including the disabled population as a whole. The current accessible toilet would make an ideal venue, in addition the current accessible toilet is not up to specification and requires work in any event. This making the time ideal for the convers I am both the lead officer within Ynghyd CIC and am a director and on the on the boards of both Anabledd Cymru / Disability Wales and Disability Rights .

I am therefore, particularly able to comment both on the individual project and on the need for and requirements of adult changing place in general, as I have specialist knowledge of both. This will inform and enhance the Council's discussion, which otherwise may be impaired by the lack of specialist knowledge.

The project is to benefit the entire community in Kidwelly and the surrounding area and will involve Ynghyd CIC contributing assets to the town facilities at a cost to Ynghyd rather than any gain, therefore my involvement is not likely to damage public confidence.

Further, my involvement in the adult changing place project is generally publicly known in any event and as such open involvement in discussions in a public meeting would assist transparency rather than impair public confidence.

Although, the constitution of Ynghyd CIC does provide for the potential payment of directors, this is a standard clause and I do receive any remuneration in the role, nor do I intend to in the foreseeable future and accordingly have no pecuniary interest in the project.

In respect of item 2: the Kidwelly Luncheon Club Project, I am again the lead director from Ynghyd CIC in this project and the main contact for the Kidwelly Community Hub.

I was the contact person in respect of the grant from the Big Lottery, which is the major funder.

The Town Council has already made its decision to grant fund the project, (in which I took no part), therefore the decision to fund has been made without any question of my involvement, therefore future discussions will be report backs and logistical or practical rather than fiscal, which I am in a unique position to participate in and inform the Council's discussion.

Further as this is a community project in which as above my involvement is well known and in which I have no pecuniary interest public confidence is unlikely to be damaged by my inclusion in the discussions.

In respect of neither project am I requesting permission to vote, merely speak and provide written representations, which will serve to inform the Council's discussion, rather than actively voting for the projects, which provides an additional check and / or balance to maintain public confidence as my non-participation in the vote will be recorded as a matter of record.
