He thereupon referred, with the aid of powerpoint slides, to the written report/addendum of the Head of Planning which provided an appraisal of the site together with a description of the development, a summary of consultation responses received and information on the local and national policies which were relevant to the assessment of the application. The Committee was advised that the Head of Planning was recommending approval of the application for the reasons detailed within her written report.

A representation was received reiterating the objections raised at the meeting on the 24<sup>th</sup> August 2017 and those detailed within the Head of Planning's Report, with the primary areas of concern relating to the location of the unit and proximity to nearby properties and health issues which could arise.

Councillor A. James, the local member, having sought advice on his position from the Head of Administration and Law prior to the meeting, declared an interest in this item, addressed the Committee in support of the planning application and left the meeting).

The applicant's agent and the Development Management Officer responded to the issues raised
