

With reference to the above application the Carmarthenshire Division of the Dyfed Powys Police will make the following representations.

- 1. The whole of the licensed area, entry and exit areas must be covered by CCTV cameras, and there must not be any hidden or obscured areas .This will deal with issues which may have arisen outside the premises when customers have been arriving or leaving.
- 2. The CCTV system at the premises must be installed by a company certified by SSAIB or NSI Gold standard
- 3. Main entrance / exit to have a camera meeting a minimum of 100%R image quality
- 4. All footage must be of good quality and of a minimum performance capability sufficient to identify individuals
- 5. It must be in colour
- 6. It must record at a minimum of 12 images per second
- 7. All images will be time and date stamped
- 8. All footage during the hours of Licensable activities to be retained for a period of 30 days
- 9. The CCTV system must operate continuously, and if a defect arises the police must be informed and immediate arrangements must be made to rectify the fault
- 10. All footage must <u>on demand</u> be made available to a police officer or PCSO for viewing and a copy of that footage made immediately available to a police officer or PCSO
- 11. At all times during the period of operation of the premises there must be a competent person on the premises able to undertake the export of recordings quickly onto a removable storage medium. Memory Stick, CD, or DVD format is acceptable to the police. The master copy will be available to the police on demand
- 12. The system must incorporate a means of transferring images from the hard-drive to a format that can be played back on any Microsoft Windows or MAC compatible computer. The application software required to launch and view recorded images must either be included as part of the standard operating system installed or be installed to the recorded media when the data is copied to that media
- 13. The system must be registered with the Information Commissioner (Tel 0303 123 1113 or email registration@ico.org.uk)

15. The challenge 25 scheme to be adopted at the premises with notices and posters to be clearly displayed in the premises, To emphasise to customers that they will be Challenged if they look 25 and under.

I was wondering if I could ask you who do I send a letter of objection to for the licence to sell alcohol at Majka Polish shop bridge Street llanybydder.

I see there is an application to sell alcohol at these premises and I know I live just outside the village I do feel quite strongly about this first due to the fact that there are two shops in Llanybydder all ready selling alcohol and due to the fact that the Polish have just recently been given suspended sentences first fighting while been drunk in the middle of Llanybydder should show that another outlet selling alcohol in Llanybydder is not necessary.

Many of the Polish either buy there alcohol in Londis or premier in the village and this is usually quite early on in the evening where some of them gather at the wooden horse on the square or in and around the band stand very close to where the Majka shop will be.

Only last month I witness 5 Polish men drinking in the car park near the band stand and they were shouting and even more worrying they were lighting fireworks they had rockets and we're lighting them and throwing them up into the sky. There were several cars parked in the car park that night and it could have caused a fire.

I witnessed these men but as they were quite obviously drinking and all had alcohol in there hands shouting in Polish to each other I felt that should anyone have said anything to them it would have been a very unpleasant situation.

I feel that having them drinking in public is not something that should be in couraged and having another outlet selling alcohol in such a small village will only in courage this kind of behaviour.

Also anyone who goes to llanybydder at night to use the local shops does not and should not feel uneasy having to see this going on also along the river bank down passed the Old vale of aeron flats the footpath along there in terms summer evenings there are Polish drinking and sitting this path is used by young children and it's has been said that they feel uncomfortable walking amount them drinking.

So I would like to object to the licence application for alcohol to be sold in the Majka shop in Llanybydder.
