In developing a Strategic Partnership of Town Councils within Key Rural Towns of Carmarthenshire, a leader funded project will aim to have a network of WiFi infrastructure in each town that allows the development of economic benefit through business growth and Comment enhancement to the visitor experience. This will also allow greater coordinated access for service users in employability and other health and welfare key services. Free WiFi trials have already been undertaken in Llandovery and Ammanford and the analysis of these pilots will be utilised to progress the project. 
