# Adolygiad Gorchwyl a Gorffen / Task & Finish Review

- Sefydlodd y Pwyllgor Grŵp Gorchwyl a Gorffen ym mis Awst 2015
- Cynhaliwyd sawl cyfarfod rhwng Tachwedd 2014 a Mehefin 2015, a ddefnyddiwyd i ystyried tystiolaeth a gwybodaeth o amrywiaeth eang o ffynonellau.
- Prif amcanion yr adolygiad oedd:
  - Clustnodi a gwerthuso gweithgareddau presennol yr Is-adran Tai a Diogelu'r Cyhoedd.
  - Nodi gwelliannau posibl a modelau darparu eraill.
  - Nodi arferion gorau cost-effeithiol gan awdurdodau, asiantaethau a darparwyr eraill.
  - Llunio argymhellion i'w hystyried gan y Bwrdd Gweithredol.
- August 2015, Committee establishes a Task & Finish Group
- Several meetings were held between November 2014 and June 2015, which were used to consider evidence and information from a wide variety of sources.
- The main aims of the review were:
  - To identify and evaluate the current activities undertaken by the Housing & Public Protection Division.
  - To identify potential improvements and alternative delivery models.
  - To identify cost effective best practice by other authorities, agencies and providers.
  - To formulate recommendations for consideration by the Executive Board.

# Beth yw Eiddo “Gwag”? / What is an “Empty” Property?

- Mae preswylfa wag yn wag o bobl. Nid yw hyn yn cynnwys:
  - Ail gartref neu gartref gwyliau
  - Preswylfa sydd newydd gael ei chwblhau ac sy'n disgwyl i bobl ei meddiannu
  - Preswylfa bresennol sy'n cael ei haddasu neu ei moderneiddio
  - Preswylfa sy'n cael ei defnyddio ond nid at ddibenion preswyl
- Ym marn Llywodraeth Cymru:  
Preswylfa yn y sector preifat sydd wedi bod yn wag am fwy na 6 mis ar 1<sup>af</sup> Ebrill, ac sy'n dal i fod yn wag.
- Ar hyn o bryd, mae 2667 o eiddo gwag yn y sector preifat yn Sir Gaerfyrddin (Ebrill 2018)
- A vacant dwelling is vacant of people. This excludes:
  - A second or holiday home
  - A newly completed dwelling that is awaiting occupation
  - An existing dwelling that is being converted or modernised
  - A dwelling that is in use but for non-residential purposes
- Welsh Government consider:  
A private sector dwelling that has been vacant for more than 6 months at 1<sup>st</sup> April, and is still empty.
- Carmarthenshire currently has 2667 private sector vacant properties (April 2018)

# Golwg gyffredinol / Overview

- Mae tua 27,251 o eiddo gwag yn Nghymru (LC – Ebrill.2018)
- Mae dros 78,000 o gartrefi yn Sir Gaerfyrddin
- Mae 2667 o eiddo yn y sector preifat wedi bod yn wag am 6 mis neu fwy
- Mae'r galw am dai fforddiadwy yn Sir Gaerfyrddin yn dal i gynyddu tra bod y cyflenwad yn lleihau ar gyfradd sy'n golygu na allwn ddiwallu'r anghenion o ran tai yn effeithiol mwyach.
- Approximately 27,251 empty properties in Wales (WG – April.2018)
- There are over 78,000 private sector homes in Carmarthenshire
- 2667 private sector properties have been empty for 6 months or more
- The demand for affordable housing in Carmarthenshire continues to increase while supply is falling at a rate that means we can no longer meet housing needs effectively.

- Create an Across Department Working Group, implementing a Works in Default budget & IT database sharing
- Consider increasing the provision of delegated powers and increase resources
- Improve access to guidance and information online, to include an online referral mechanism.
- Explore the use of HRA funding



- Creation of a second Officer post
- Website has been improved and updated, with a direct referral mechanism



# High Street, Llanelli





- Benthyciadau di-log ar gyfer gwerthu neu osod
- Uchafswm o £25,000 yr uned
- Dyrannwyd £1.9 filiwn i'r Sir



- **Houses into Homes**

- Welsh Government funded scheme
- Interest Free Loans for Sale or Let
- Maximum £25,000 per unit
- £1.9 million County allocation
  - Approved - £1,712,823
  - Units created – 70
  - Recycled Funding - £912,379



## Enforcement (by agreement)

- Notice served (HA.2004, S.12)
- Costs for service (HA.2004, S.49)
- Appeal period expiry
- Local Land charge
- Owner confirms she cannot comply



## Non-compliance

- Best course of action – Works in Default
- Written consent to proceed with EDMO
- HA.2004, S.31 & Schedule 3 notice
- Council project manage renovation works
- Demand to Recover Expenses - Schedule 3, para.9
- Financial charge & restriction - Land Reg.

- Cyflwynwyd cais ffurfiol dan Ddeddf Tai 2004, Adran 134 i'r Tribiwnlys Eiddo Preswyll
- Caniatâd i gyflwyno Gorchymyn Rheoli Anhedduau Gwag dros dro
- Rhoddyd yr eiddo i'r asiantaeth Gosod Syml ar gyfer ei ddyrannu i denantiaid ar y Gofrestr Dewis Tai
- Cynllun rheoli – Gorchymyn Rheoli Anhedduau Gwag Terfynol

## Empty Dwelling Management Order

- Formal application under HA.2004, S.134 submitted to RPT
- Consent to serve an Interim EDMO
- Property handed to Simple Lettings for allocation to tenants on Housing Choice Register
- Management scheme – Final EDMO
