REASONS:

Targeted Finance Fund – (TFF)

The South West Wales Economic Regeneration Strategy has identified the need to develop meaningful relationships with Key Account Businesses (KAB's) who are a mix of private, public and third sector.

With this in mind, the Bureau Team in Carmarthenshire is working along the same theme by delivering a local tailored and focused Key Account Management (KAM) service for Third Sector Organisations.

The Key Account Management service creates a supportive and proactive environment for Third Sector Organisations that have growth potential or who deliver vital services within our County.

To compliment this, the Bureau has introduced a pilot tailored, targeted finance support fund for projects that will deliver on economic growth in line with the South West Wales Economic Regeneration Strategy.



Welsh Church Fund – (WCF)

Carmarthenshire County Council has established the following criteria on an interim basis in order to aid the administration of the Welsh Church Fund under Section 19 of the Welsh Church Act 1914.

Organisations must be either Carmarthenshire based, or if of a national and regional character must be able to demonstrate that the money requested would be used for a specific Carmarthenshire based project.

Organisations that can apply for **Revenue and Capital projects**, to a maximum of £3,000, unless total project costs are in excess of \pounds 100k, and are then eligible for a maximum of \pounds 10k
