# EXECUTIVE SUMMARY Executive Board 30<sup>TH</sup> NOVEMBER 2015

## Renaming of the Liaison Meeting for Opposition Spokespersons

The Council, at its meeting on the 10th July 2002 agreed to the establishment of a Shadow Executive Board as a means of enabling the Chief Executive and Directors to inform/consult with the Opposition Group on matters relating to policy/executive action, subject to its terms of reference being endorsed by the Council.

Subsequently, Council, at its meeting held on the 9th October 2002 considered a report from the Executive Board setting out the proposed terms of reference. Whilst accepting the Board's recommendations, Council also accepted the Board's view that whilst there was merit in a system which recognised the position of opposition spokespersons, it should be without the formality that attends the establishment of a formal 'shadow arrangement' and accordingly 'Resolved that the arrangements for liaison meetings with opposition spokespersons as set out in the report be accepted'.

At the meeting of the Opposition Spokespersons held on the 24th September 2015 it was suggested that the meeting should be renamed the Shadow Executive Board to more accurately reflect its purpose of shadowing the Executive Board. Whilst the Group Leaders have been consulted, and have no objection to the proposed title change, as the meeting had been formally established by Council then, for the purposes of Governance, any name change needs to be referred to the Executive Board for confirmation
