Brecon Beacons National Park Authority, Mid and West Wales Fire and Rescue Authority and the Constitutional Review Working Group.

The Chief Executive received notice from Councillor Colin Evans that he had resigned from the Labour Group on 28th July 2019, subsequently Cllr Evans joined the Plaid Cymru Group on the 4th September 2019.

As a result of revised political balance calculations:-

- the Labour Group will need to relinquish a seat on the Council's Pay Policy Advisory Panel to the New Independent Group and,
- the Independent Group will need to relinquish a seat on the Dyfed Powys Police & Crime Panel to the Plaid Cymru Group.

Following discussion with the Groups: -

- The Independent Group has relinquished the seat held by Councillor Jim Jones on the Dyfed Powys Police & Crime Panel. The Plaid Cymru Group will put forward their nomination for this seat at the meeting.
- The Labour Group has relinquished the seat held by Councillor John Prosser on the Council's Pay Policy Advisory Panel and the New Independent Group has nominated Councillor Jeff Edmunds to take this seat.
