Carmarthenshire County Council has established the following criteria on an interim basis in order to aid the administration of the Welsh Church Fund under Section 19 of the Welsh Church Act 1914.

Organisations must be either Carmarthenshire based, or if of a national and regional character must be able to demonstrate that the money requested would be used for a specific Carmarthenshire based project.

Organisations that can apply for **Revenue and Capital projects**, to a maximum of £3,000, unless total project costs are in excess of £100k, and are then eligible for a maximum of £10k
