In terms of specific regulated entertainments please note that:

- Plays: no licence is required for performances between 08:00 and 23.00 on any day, provided that the audience does not exceed 500.
- Films: no licence is required for 'not-for-profit' film exhibition held in community premises between 08.00 and 23.00 on any day provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.
- Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
- Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
- Live music: no licence permission is required for:
 - o a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iil) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
- Recorded Music: no licence permission is required for:
 - o any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.





Further to the receipt of the above application, the Licensing Authority make the following representations:

a) Previous Enforcement Action / Prosecutions

The premises licence holder, Gryphon Leisure Ltd, accepted a formal caution issued by the authority in 2010 for carrying out licensable activities at the premises other than in accordance with an authorisation under S136 of the Licensing Act 2003. The caution related to the provision of unlicensed entertainment in the rooftop lounge and a breach of the inaudibility licence condition.

b) Complaints.

The department received complaints regarding noise nuisance from a local resident, which lead to the caution outlined above. A further complaint relating to noise nuisance has been received on the 5th of September 2017, this complaint is currently being investigated by Environmental Health Officers.

c) Responsible Authority Referrals.

The licensing authority is liaising with Environmental Health Officers in relation to the recent complaint regarding noise.

d) Relevant Sections of the Statutory Guidance.







The Licensing Authority believes that the following sections of the Statutory Guidance are relevant to this licence application: - Section 1 Introduction, Section 2 relating to The Licensing Objectives, Section 5 relating to Premises licences, Section 8 relating to Applications for Premises Licences and Section 10 relating to Licence Conditions.

e) Relevant Sections of the Local Licensing Policy.

The Licensing Authority believes that the following sections of Carmarthenshire's Licensing Policy are relevant to this licence application:Section 3 Fundamental principles, Section 4 Conditions of Licence, Sections 5
– 9 relating to The Licensing Objectives and Section 11 relating to Licensing Hours.

f) Proposed Operating Schedule.

Having considered the current application, which seeks to remove a licence condition which limits the use of the rooftop lounge to hotel residents only and the operating schedule put forward by the applicant, the Licensing Authority believes that, if the application were granted, the wording set out in the operating schedule, which refers to the existing licence conditions, is not sufficiently precise to enable it to form clear enforceable licence conditions in accordance with section 18(2)(a) of the Licensing Act.

The Public Health section have submitted a letter of representation in relation to the application. The representation requests that additional information be provided by the applicant as to how they intend to ensure that the use of the rooftop lounge does not cause a public nulsance.

Given the previous complaints and subsequent enforcement action in relation to this area of the premises coupled with recent changes to the Licensing Act 2003 which permits alcohol licenced premises to provide live and recorded music between 8.00am and 11.00pm without specifying those activities on the premises licence, the licensing authority also requests that the applicant provide further detail regarding proposed control measures. Consideration could then be given as to whether it would be appropriate to attach those control measures as licence conditions should the application be granted.

Several representations have been received from other parties, who live in the vicinity of the premises, which highlight a number of complaints regarding the effect that the operation of the premises is having on local residents. The subcommittee will have to be satisfied that granting the amendment requested in the application will not undermine the licensing objectives.

These representations have been prepared on the 1st of November 2017 with the benefit of viewing the original application and representations from Public Health services and other parties.

I would be grateful if the applicant could contact me to discuss the above representations at the earliest opportunity and certainly prior to the application being referred to a Licensing Sub Committee hearing for determination.

- The Stradey Park Hotel was originally granted the use of the rooftop lounge for residents only. They are already in breach of this as they currently use the lounge for afternoon teas and other meetings and events for the general public.
- Concern that if this is granted they will abuse that licence even further for other events and parties.
- This is not a soundproof building and noise would be an issue as the building sits on the highest point in the village and noise would reverberate across the valley.
- There is already ample facilities in the hotel and this is not required.
- There is already two pubs in the village providing this service.
- It is a matter of public safety, the emergency exit has been cleared and a designated path with lighting leads on to a private road which would be in danger of being used for overflow and illegal parking and in time that exit would be used more and not in an emergency only.

I wish to complain in the strongest terms about the above application. On the grounds of -

- 1. The Protection of Children from Harm.
- 2, The Prevention of Public Nuisance.

Over the years, the level of noise and disturbance endured by my self and my family has been considerable. This will only increase if what amounts to a "Roof Top Pub" opens on a massively over developed sight that operates relentlessly 24 hours a day, 7 days a week, 365 days a year.

The current level of noise seems to be getting out of hand with ever increasing frequency and volume. I have made countless phone calls to the Hotel to respect the residents and the terms of their licence. Indeed, I have had occasion to phone so often that I am now on first name terms with Tim, Tom and the rest of the duty management team!

My elderly mother, Inlaws ,Young nephews and grand daughter have all been disturbed at various times whilst visiting my home. I feel I have the RIGHT to enjoy some peace and quiet in my own home, and I also feel I should speak up for all the young children, the elderly and the less able or Infirmed people in the village that endure broken sleep and Statutory Nuisance (under the terms of the "Noise and Statutory Nusance Act 1993") and feel powerless to stand up to the might of Gryphon Leisure.

The Residents Lounge was built for the exclusive use of resident as a quiet retreat for hotel guests from the busy public spaces of the hotel. Planning was granted, and a plastic Conservatory type building was constructed for this express use. As such, the Residents lounge is wholly unsuitable to being used as a public restaurant. It is at the same level as the top floor of the newer accommodation block, has No dedicated access to the kitchen and all food has to travel some distance and then up the Guests stair well or the Guests lift.

It is common knowledge that the Sale of Alcohol to the Public, is already ongoing in the Residents Lounge and always has been, in direct violation of their existing Licence. Hen Parties, Birthday Parties and Cocktail parties are but a few of the uses the Residents Lounge has been put to. 


