### **EXECUTIVE SUMMARY**

## ENVIRONMENT & PUBLIC PROTECTION SCRUTINY COMMITTEE

### HIGHWAY FOOTWAY AND ROAD SAFETY STRATEGY INVESTMENT PROGRAMME UPDATE

### 1.0 Introduction and Background.

- 1.1 The County Council employs many measures to prevent road traffic casualties including education, publicity campaigns, training, traffic management and other road safety initiatives as well as the construction of a number of road safety improvement schemes each year. The overall strategy is outlined in the Carmarthenshire County Council Local Transport Plan which is contained within the Joint Local Transport Plan for South West Wales.
- **1.2** These measures are funded from a variety of sources including both capital and revenue grants and other funds which are summarised as follows with further details provided in the Summary Table at the end of the report.

### 2.0 Local Transport Plan / Local Transport Fund

- **2.1** The South West Wales Integrated Transport Consortium (SWWITCH) was formally dissolved in early 2014 and Welsh Government required local authorities to prepare a Local Transport Plan. The four West Wales local authorities agreed to continue a collaborative approach which is linked to the Swansea Bay City Region and the emerging City Deal. The priorities within the Carmarthenshire County Council Local Transport Plan (LTP) were approved in 2015.
- **2.2** Funding which was previously allocated to the Regional Consortium is now allocated to the individual local authorities on a competitive basis and bids for the Local Transport Fund (LTF) are submitted to Welsh Government on an annual basis. This LTF Grant is subject to an ever increasing level of scrutiny as the all Wales funding is limited.

  Carmarthenshire County Council secured LTF funding of £2,070,000 in the current financial year towards 3 schemes.

### 3.0 Local Transport Network Fund

**3.1** Local Authorities prepared and submitted Local Transport Plans (LTPs) to the Welsh Government; the four authorities in South West Wales worked collaboratively to create an overarching City Region LTP (with four local programmes of projects and the joint LTP providing the framework for improving connectivity to, from and within the region) for the period 2015 to 2020 - funding is now allocated to the individual local authorities on a competitive basis [bids for the Local Transport Network Fund (LTNF) to be submitted to Welsh Government annually].



**3.2** LTNF Grant provides a funding opportunity for the Authority to deliver projects / implement measures so as to improve public transport journey time reliability, to reduce public transport journey times and to connect communities and enable access to employment, education and key services.

In the current financial year, LTNF funding of £450,000 was awarded for Carmarthenshire Strategic Public Transport Corridors.

### 4.0 Active Travel Act and Local Authority Obligations

- **4.1** The Active Travel (Wales) Act makes provision for a number of items including the development of approved maps of existing active travel routes, the promotion of active travel journeys and to enhance the provision made for walkers and cyclists among others.
- **4.2** A number of key obligations have been passed to Local Authorities to implement, including the mapping of routes, the need to have regard for the active travel route network in the development of transport policies, the promotion of active travel journeys and to enhance the provision made for walkers and cyclists.
- **4.3** One of the obligations involved Welsh Government requiring all Local Authorities to submit details of all walking and cycling routes for inclusion in all Wales database of such routes (known as Existing Route Map). These details included an audit of all routes and Carmarthenshire County Council were one of only five Local Authorities that secured Welsh Government approval without the need for further work. The Authority was also required to submit an Integrated Network Map (INM) during 2017 which has subsequently been formally approved by Welsh Government.
- **4.4** Welsh Government have recently advised that future funding for Active Travel related projects will be based on these INMs.

In the current financial year 2019-20 a total of £316,000 has been awarded for the development of routes identified on the INM for works such as feasibility studies, scheme design, land purchase and consultation/engagement.

In addition to this funding we have secured £1,641,000 for capital works constructing schemes identified on the INM. These include upgrade of the active travel network in South Llanelli and the construction of shared use link toward Hendy.

### Year 2020/21: Welsh Government Transport Grants & Active Travel Fund Grant

Welsh Government Transport Grants and Active Travel Fund Grant funding is allocated to individual local authorities across Wales on a competitive basis; to support / enable schemes and proposals to develop integrated, effective, accessible, affordable, safe and sustainable transport systems, modes and networks.



A number of bids are currently being drafted for submission to Welsh Government by 14<sup>th</sup> February 2020 - to include such proposals as:

- Cross Hands Economic Link Road
- Llanelli Urban and Coastal Belt Network Improvements
- Towy Valley Path
- Access to Pembrey Country Park
- Ammanford Distributor Road
- Strategic Public Transport Corridors // Modernising Services Public Transport
- Active Travel (3no. geographical schemes)
- Electric Vehicles Charging Hub (Cross Hands)
- Package of extreme weather resilience measures (mix of infrastructure and monitoring equipment)

### 5.0 Safe Routes in Communities

- **5.1** The Safe Routes in Communities (SRiC) grant provides direct funding from the Welsh Government for the County Council to deliver projects that create or enhance active travel within communities with the aim of improving accessibility and safety. This will help create greater social inclusion and improved community safety. Safe Routes in the Communities funds capital works such as: -
  - crossings
  - traffic calming measures
  - shared use paths
  - footpaths
  - secure cycle facilities (including stands), lockers and changing facilities.
- **5.2** The County Council must bid for this funding on an annual basis. The Welsh Government has advised that schemes must link directly with the Integrated Network map or have been included in a schedule of works to upgrade safe walking routes to schools included in a response to the Minister in the summer of 2014. Carmarthenshire County Council has been highly successful in securing this SRiC funding being consistently among the highest awards for this particular grant.

Two projects are included in the current financial year for works in the Llanelli West and Ammanford/Betws areas; a total of £849,744 funding secured for these areas.

Bids listed below for next year's SRIC funding have been submitted to Welsh Government on 24<sup>th</sup> January 2020:

- Llwynhendy £823,080
- Ammanford & Betws Phase 2 £423,500



### 6.0 Road Safety Improvement and Footway Improvement Programme

- **6.1** At its meeting on the 14<sup>th</sup> November 2011 the Executive Board approved the criteria for assessment, selection and prioritisation of Road Safety Improvement and Footway Improvements to be funded from the Council's capital budget allocation for such works. A new 3 year rolling programme was developed and implemented from 2013-14. The criteria for assessment was updated in the spring of 2017 and formally approved by Executive Board on 27<sup>th</sup> February 2017.
- **6.2** During the summer of 2017 the prioritised programme was reassessed in accordance with the criteria to determine the 3 year rolling programme (commencing in 2018-19); the schemes will be subject to further feasibility works in future years, subject to the availability of funding.
- **6.3** Previously committed schemes continue to be developed and implemented as funding and any other constraints permit.

### 7.0 Local Road Safety Grant (Capital & Revenue)

- **7.1** The Road Safety Grant was introduced in 2000. The Capital Grant provides direct funding from the Welsh Government for the County Council to provide engineering solutions to road safety problems on the county road network. The Revenue Grant is used to provide a programme of road safety related education and training initiatives.
- **7.2** The County Council must bid to the Welsh Government for both capital and revenue funding on an annual basis. The revenue allocation is set for each LA by use of a formula based on the latest available population numbers (60%) and casualty numbers of those killed or seriously injured (40%).
- **7.3** The County Council prioritises the selection of road safety engineering projects for its capital bids on the basis of historic collision and casualty statistics along rural routes and at urban cluster sites. The Council assesses the collision and casualty reduction performance of each scheme delivered using the grant. There is a strong partnering approach to all initiatives funded from this grant through groups such as the Carmarthenshire Speed Limit Working Group with bodies such as Dyfed Powys Police and GoSafe.
- **7.4** For its revenue bids priority is given to high risk groups of young people and motorcyclists and also to child pedestrian and cycling training. The programmes are designed to improve people's awareness, knowledge, skills, and behaviour and develop safer attitudes towards using the highway.
- **7.5** Bids listed below for next year's Road Safety Grant funding have been submitted to Welsh Government on 24<sup>th</sup> January 2020:

### 8.0 Traffic Management and Accident Prevention Programme

- **8.1** The following traffic and accident prevention elements are provided on the county road network using the Councils revenue budget allocation for such works: -
  - Traffic orders for speed limits, one way working, weight restrictions, width restrictions, buses only, no entry order, no motor vehicles order, disabled persons parking bays, waiting restrictions, residents parking zones;
  - Traffic calming elements, road humps, narrowing's and chicanes, gateway and entry treatments, vehicle activated message signs, speed limit roundel markings, coloured surfaces, surface texture – skid resistant material;
  - Hatched road markings, countdown signs, bollards, disabled parking bays.
- **8.2** The current programme of traffic management and accident prevention projects being delivered using the revenue funding is shown in the Summary Table at the end of the report.

### **Risk Management Issues**

Highway verges are mown primarily to ensure the safety of the travelling public and a risk based approach is adopted on all verge moving areas. Particular attention is given to junctions and bends to ensure visibility.

### **Physical Assets**

Carmarthenshire has the second largest highway network in Wales and much of that network is rural in nature. This rural network provides significant 'green' corridors of highway verge which we manage, within the resources we have available, to ensure public safety but also with a high regard to biodiversity and promoting natural habitats.

### **ACTION PLAN MONITORING REPORT**

### TASK AND FINISH ACTION REVIEW 2017/18 – A Review of the Maintenance Provision of Highway Hedgerows and Verges

### 1. Introduction and Background

- 1.1 The Environmental & Public Protection Scrutiny Committee of 17<sup>th</sup> November 2017, agreed to establish a task and finish group to review the current maintenance provision of highway hedgerows and verges.
- 1.2 It was agreed that the main objective for the review would be to:

To review the current provision for the maintenance of highway hedgerows and verges and if appropriate make recommendations for service change.

- 1.3 The group was chaired by Cllr. John James and had a politically balanced Elected Member representation of 6 County Councillors
- 1.4 A total of 8 meetings were held (January 2018-November 2018).

### 2. Scope and Objectives of the Group's work

**2.1** The Committee agreed the scope, aims and objectives for the work as set out below:

### Scope:

'To review the current provision for the maintenance of highway hedgerows and verges and if appropriate make recommendations for service change.'

### 2.2 Objectives:

- Review the number of staff carrying out the service.
- Review the number of times roadside hedges and verges are cut with particular focus on hedges around Junctions.
- Review the requests for services process in relation to hedge cutting demands from the public.
- Environmental impact including biodiversity



### 2.3 Corporate objectives and well-being objectives

The review would contribute towards achieving the following corporate objectives and well- being objectives:-

- County Council's Corporate Strategy 2015-20
- Well-being objectives:-
  - ➤ In a Healthy & Safe Environment:-
    - Objective 12 Looking after the environment now and for the future
    - Objective 13 Improving the highway and transport infrastructure and connectivity

### 2.4 Main aims of the review

- To review the current maintenance provision and programme for County roads. Including the nature, timing and equipment used for cuts.
- Consider the current maintenance provision and programme for Trunk roads.
- To review the balance between in house and external services and procurement of those services.
- To review the number of staff carrying out the service. (e.g. has there been a
  detrimental impact in service due to the reduction of staff (based on previous
  years).
- To review the number of times roadside hedges and verges are cut with particular focus on hedges around junctions.
- To review how much contact demand the Council receives about this issue and the request for services process for hedge cutting demands from the public. To include both requests to cut and not to cut.
- To review the budget allocation and the impact of any changes to the provision.
- Consider landowner responsibilities and enforcement powers of the Council.
- Consider the environmental impact including biodiversity.
- To formulate recommendations for consideration by the Executive Board.

### 3. Methodology

Throughout the review the Group considered evidence and information from a variety of sources. Each session was designed to provide the Group with the relevant information, context and background to the topic. Officers from Highways, Conservation and Waste and Environmental Services provided specialist advice and support during the Group's review

Furthermore, as part of the research, the task group interviewed the local contractors to ascertain their views on their experience of being a local contractor and the tendering process.



### 4. Report Conclusions

Following the review, the Task and Finish Group trusted that the Council undertook a thorough and effective job in ensuring that highways were kept safe for those who use them. The Group concluded that there was a general public perception that all roadside hedges were the Council's responsibility.

In order to alleviate some of the issues experienced by both the Council and the Contractor, the Group suggested that:

- There is a clear rationale to the current regime for maintaining rural highway verges but needs greater flexibility to facilitate further environmental enhancement for biodiversity.
- There are common misconceptions regarding duties and responsibilities for hedges, verges, ditches and grips which would benefit from clarification, potentially through the publication of an information brochure.
- There are opportunities to be investigated to encourage local farmers and contractors to tender for contract work.
- Greater availability of guidance and support for local farmers and contractors in relation to bid for works would be beneficial to the local economy and encourage a greater consistency of cutting throughout the County.
- The verge maintenance regime should consider greater flexibility to allow the early cutting of lower class roads in instances where the safety of higher class roads is not compromised.
- Opportunities to work collaboratively with Town and Community Councils should be investigated further, particularly with respect to urban highway verges and amenity grass cutting.
- Whilst litter remains a challenge, the Council could promote a clear message to drivers to take their litter home.



### 5. Report recommendations

The research undertaken by the Task and Finish group during the review on the current maintenance provision for highway verges resulted the following recommendations:-

### **Recommendation One**

That the County Council's Environment Directorate should largely continue with its current provision for maintaining rural highway verges but considers adopting greater flexibility to:

- a) Facilitate further environmental enhancement for biodiversity, such as late or biennial cutting of selected areas, or other appropriate management provision;
- b) Consider the early cutting of minor roads in instances where the safety of main roads is not compromised.

### **Recommendation Two**

That the County Council's Environment Directorate raise public understanding of highway verges as important areas for care, maintenance and habitat by:

- a) Providing a Carmarthenshire County Council guide to highlight the roles and responsibilities of the highway authority and adjacent landowners.
- b) Programming targeted campaigns to discourage the littering of verges and promote public awareness of highway verges and hedges as valuable natural habitat.
- c) Including clear information on the Council website with specific regard to the conservation and management of roadside verges.

### **Recommendation Three**

That the County Council seeks to safeguard the highway maintenance budget as far as possible to ensure the safety of the travelling public, reduce future liability and protect key habitats.

### **Recommendation Four**

That the County Council's Environment Directorate promotes opportunities to encourage local farmers/contractors to tender for work and engage with potential bidders to explain the tendering process.

### **Recommendation Five**

That the County Council's Environment Directorate work collaboratively with Town and Community Councils to promote a more proactive role in managing and maintaining verges, hedges and landscaped areas, equally in both urban and rural areas.

Public awareness and understanding of the management of highway verges has been taken forward through the following actions:

- a. A brochure entitled Adjacent Landowners and the Public Highway: A guide to roles and responsibilities has been published and is available on Carmarthenshire County Council website. The brochure has also been publicised to Town & Community Councils. - b. The Council's approach to litter has been set out within our new Litter Management Plan and a number of initiatives are underway to raise public awareness of both littering and the recognition of highway verges as a valuable habitat. Projects such as 'Pride in your Patch', have been publicised on Radio Carmarthenshire which bring together volunteers and key partners including Town and Community Councils, fast food outlets, major employers and schools to promote anti-litter campaigns and undertake clearance works.
- c. Information has been updated on the County Council's website and includes Ecological Advice Note 11: Managing Road Verges for Safety and Biodiversity.

### 4. REVENUE BUDGET STRATEGY CONSULTATION 2020/21 TO 2022/23

The Committee considered the Revenue Budget Strategy 2020/21 to 2022/23 (Appendix A) which had been endorsed by the Executive Board for consultation purposes at its meeting on 6<sup>th</sup> January 2020. The report provided Members with the current view of the Revenue Budget for 2020/2021 together with indicative figures for the 2021/2022 and 2022/2023 financial years. The report was based on officers' projections of spending need and took into account the provisional settlement issued by Welsh Government on 16th December 2019.

The Head of Financial Services advised whilst the announced provisional settlement represented an increase of 4.3% as an average across Wales on the 19/20 settlement, Carmarthenshire had received an increase in WG grant of 4.4% (£11.5m) taking the Aggregate External Finance to £274.159m for 2020/21. This increase was after certain transfers into the funding for Teachers Pensions and Pay, which were only partially funded within the settlement and accounted for some £5.8m of the overall funding increase.

The Committee noted that the current projection for the Revenue Outturn for 2019/20 and that the main reasons for the Environmental Department overspends were primarily due to an increase in ALN pupil transport numbers and a shortfall in planning application income.

The report included details of the Welsh Government Service Specific Grants which were provided alongside the provisional settlement at an all Wales level. Whilst many remained at a broadly similar level, the Committee noted the all-Wales reduction of £1.8m to the Sustainable Waste Management Grant, which would reduce the support for Carmarthenshire's core waste budgets by around £110k.

In summary, the budget proposals assume the full delivery of all savings proposals, together with the identification and delivery of the shortfall in savings proposals 2021/22, and 2022/23. Further cost reductions would need to be identified and/or larger council tax increases be agreed to deliver a balanced budget for the latter two years. Furthermore, given the scale of the pressures and forecasted budget gap, Council Tax increases have been maintained at the previous MTFP levels of 4.89% in each of the three financial years which offers some mitigation to the savings proposals.

Furthermore, it was reported that due to the delay in receiving the provisional settlement, the consequential impact on Welsh Government's budget finalisation and publication had been equally delayed. Therefore, the final settlement was due to be published on 25<sup>th</sup> February, 2020 and the County Council would set the final budget on 3<sup>rd</sup> March, 2020.



The Committee thereupon considered the following detailed budget information appended to the Strategy relevant to its remit:

- Appendix A(i) Efficiency summary for the Environment and Public Protections Services;
- Appendix A(ii) Growth Pressures summary for Environment Service;
- Appendix B Budget monitoring report for the Environment and Public Protection Services;
- Appendix C Charging Digest for the Environment and Public Protection Services.

The following questions/issues were raised on the report:-

• Reference was made to Appendix A(ii)-Growth Pressures. It was asked if the annual £230k spend on food waste bin liners was a necessary cost? The Head of Waste and Environmental Services explained, a recent analysis of the content of black bags observed that 25.8% of the black bag content in Carmarthenshire was made up of food waste and prior to the introduction of the liners it was observed from the monitoring of kerbside collection, that household food waste recycling participation did not exceed 50%.

Furthermore, feedback from a Household Waste and Recycling Service Consultation had identified that of the respondents who said that they did not partake in recycling their food waste, 64% said that they would be more likely to do so, if they were provided with free liners. Therefore, in order to support the transition of food waste from black bags into the food waste recycling scheme, food waste liners were introduced to all householders in Carmarthenshire in October 2019.

In terms of treatment costs, an increase in food waste would result in an approximate decrease in the overall annual treatment spend, whilst enabling the Authority with the ability to meet statutory targets thus avoiding the risk of a fine.

It was therefore reported, that the annual cost of the liners was necessary as it outweighed the costs associated with the method of extracting food waste placed in black bags and the financial impact on the operational vehicles, improving the efficiency of the collection and reducing vehicle breakdowns attributed to the collection of loose food.

Members reported that since the introduction of food waste bin liners, positive feed-back had been received from residents particularly in relation to hygiene and in deterring vermin.

• With reference to Appendix C - Charging Digest, concern was expressed that the income generated from providing MOT testing to the general public at a rate lower than the maximum rate set by the DVSA (Driver and Vehicle Standards Agency) was providing an unfair platform for the local private sector. It was asked, if the Authority had considered the impact of this on its competitors?

The Head of Transportation and Highways explained that whilst the maximum possible charge for Class 4 was £54.85 as set by DVSA, the price set by the Authority was deemed to be competitive for the local market with competitors also decreasing their prices. Furthermore, the Authority did not carry out any repairs on vehicles, only providing an independent MOT testing service, ensuring an objective test with unbiased results.

In response to a further query, the Head of Transportation and Highways stated that maintenance on hire/lease vehicles was charged on an hourly basis and only carried out as part of the suppliers hire/lease contract arrangements.

• Concern was expressed regarding the draft proposal to close the Household Waste Recycling Centre (HWRC) in Whitland. It was commented that the recycling centre was a much needed provision in the area with the next closest located in Nantycaws, Carmarthen. The Head of Waste and Environmental Services explained that the closure of the HWRC facility proposal was purely a financial consideration on the basis that the Whitland facility was the smallest out of the four HWRC facilities in Carmarthenshire which made the least contribution to the Councils overall waste recycling targets. The proposal was not related to the performance of the facility. It was also reported that the closure would also achieve a saving of £80k from year 2 in 2021/22.

In response to a further comment in relation to the performance targets, the Head of Waste and Environmental Services acknowledged that whilst the HWRC at Whitland had been meeting its recycling targets, it only served 7% of the County thus making the least contribution to the Councils waste recycling targets. It was emphasised that a full consultation on this proposal would be undertaken in due course.

• Reference was made to School Crossing Patrols. Whilst it was noted in the comment that 'the school crossing patrols section has reviewed all patrols to identify where there is no requirement to provide them according to the National Safety criteria', it was asked if any surveys had been undertaken in relation to the proposal to not fill future vacancies that arise in the sites that do not require school crossing patrols? Concern was expressed that School crossing patrols were an area of safety for all ages and residents.

The Head of Transportation and Highways explained that School Crossing Patrols were provided where the National Safety Criteria required them, and that the Council funded around 50% of crossings located at other locations where the criteria had not indicated a Patrol was required. The draft proposal was to retain the Patrols where they were required but phase out patrols where there was no requirement according to the criteria. Members were assured that each site would be subject to its own review.

- The Head of Transportation and Highways, in response to a request for an update on the Road Safety Manager vacancy, stated that a Road Safety Manager was currently being recruited. Furthermore, a temporary vacancy had arisen within the Road Safety Unit which had also been advertised.
- A query was raised regarding the different pricing structure for car parks throughout the County, the Head of Transportation and Highways explained that the car parking charges applied were banded primarily on the level of activity and social demographics of the surrounding area.

### **RESOLVED that:**

- 4.1 The 2019/20 2021/22 Revenue Budget Strategy Consultation be received;
- 4.2 The Charging Digest for the Environment and Public Protection Services, as detailed in Appendix C to the report be endorsed.

### 5. REVENUE AND CAPITAL BUDGET MONITORING REPORT 2019/20

The Committee received for consideration the budget monitoring reports for the Environment Service, Public Protection Service and the Community Safety Service as at 31<sup>st</sup> October 2019 in respect of the 2019/20 financial year.

The following questions/issues were raised on the report:-

- In response to a query raised in relation to the monitoring update provided for waste services within Appendix C, the Head of Waste and Environmental Services explained that in order to assist in addressing the budget position, a report containing the preliminary high-level outcomes/options of the Waste Collections Service Review would be presented to Committee members for consideration in due course, but this unlikely to be before April 2020.
- Reference was made to the progress update which stated that the green waste collection service was not yet self-financing. A further update was requested. The Head of Waste and Environmental Services echoed the comment provided within the report in that the service was not anticipated to break-even this financial year, as per the original business plan. Currently, the service had circa 4,500 customers, however it was hoped that further marketing would increase customer levels facilitating towards the service to break-even in future years.
- It was commented that as the report provided was up to October 2019 a verbal update was requested with regard to Appendix F, managerial and policy savings 'off target'. The Director of Environment provided reassurance to Committee Members that the department was actively managing and continuously addressing the issues that were off target.

UNANIMOUSLY RESOLVED that the report be received.



#### 6. **ENVIRONMENT DEPARTMENTAL BUSINESS PLAN 2020-23**

The Committee considered the Draft Environmental Departmental Business Plan 2020 - 2023 which outlined the priorities for the department and identified how the department supported the five ways of working and the goals of the Well-being of Future Generations (Wales) Act 2015. The report included extracts of the aspects relevant to the Environmental and Public Scrutiny Committee including the following elements:-

- Highways and Transport
- Waste and Environmental Services
- **Business Improvement**

The following issues were discussed during consideration of the plan:

- It was suggested that it would be beneficial to include the Environment Departmental structure within the plan in order to provide Councillors with a visual representation of departmental roles. The Director of Environment agreed, however urged Members to continue to utilise the Democratic Services Unit recording system to ensure that all requests/complaints are recorded, managed and monitored appropriately.
- In relation to target completion dates on key actions and measures, it was queried what happens in cases where it had been necessary to change the completion dates. The Principal Business and Development Officer explained that all key actions, measures and progress were recorded on the internal Performance and Information Management System (PIMS) and it was rare for target dates to be changed. However, should any target dates significantly change in future, the Committee would be notified accordingly.

RESOLVED that the Environment Departmental Business Plan 2020-2023 be received.

#### 7. **COMMUNITIES DEPARTMENTAL BUSINESS PLAN 2020-23**

The Committee received the Communities Departmental Business Plan 2020 - 2023 which provided Members with comprehensive overview of the Communities Departmental progress. It was noted that whilst the plan enveloped the whole of the Departments' priorities, the Committee's role was to scrutinise the Public Protection elements set out on 29 of the plan.

The Head of Homes and Safer Communities informed the Committee that the department had focussed on integrating the Environmental Protection Service Delivery actions into the Divisional Plan which had eliminated the need to develop a separate Environmental Protection Service Delivery Plan.
