While they can bring much enjoyment to some people, they can cause significant fear for other people also Animals.  
Animals affected not only suffer Psychological distress but can also cause them to Self Harm.

I therefore call on CCC to require all Public Fireworks display within the Local Authority Boundaries to be Advertised in Advance of the Event, allowing Residents to take necessary precautions for their Animal and Venerable Peoples Welfare.

To actively promote a Public Awareness Campaign about the impact of Fireworks on Animal Welfare and Venerable people. Including the precautions that can be instigated to mitigate the Risks.

To write to Uk/ Welsh Government. Urging them to introduce Legislation to limit the Maximum noise levels of the fireworks to 90 dB of those Sold to the Public for Private Display.

To encourage Local Suppliers of Fireworks to Stock a “Quieter Version” of Fireworks used for Public Displays etc.
