1. DECLARATIONS OF PERSONAL INTEREST

There were no declarations of personal interest.

2. DECISION RECORD - 16TH JULY, 2020

RESOLVED that the decisions record of the meeting held on the 16th July 2020 be signed as a correct record.

3. NON-RESIDENTIAL CHARGING 2021-22

The Executive Board Member considered a report detailing the potential impact, and effect, of changes to charges for non-residential services and the need for charges in Carmarthenshire to increase in order to continue to maximise income.

To gain full cost recovery for 2020-21, and to align rates with other local authorities in Wales, it was proposed to increase Non-Residential charges for hourly charged services from £16.50 to £16.85 (2.12%) and Day Care and Adult Placement charges from £16.15 to £16.50 (2.17%).

It was noted that increasing charges would not necessarily increase income this year because the amount anyone can pay is controlled by the current Welsh Government "Cap" and Financial Assessment, but there may be a small marginal increase of income from the inflationary uplift applied to the full cost, small packages of care.

RESOLVED that Carmarthenshire increase its Non-Residential charges for hourly charged services by inflation from £16.50 to £16.85 (2.12%) and Day Care and Adult Placement sessional charges from £16.15 to £16.50 (2.17%) in order to recover as much revenue as possible within the rules set down by Welsh Government for 2021-22, and to align rates with other local authorities in Wales, and in particular to move closer to regional Local Authorities.

LOCAL AUTHORITY RESIDENTIAL CARE STANDARD CHARGE FOR 2021-2022

RECOMMENDATIONS / KEY DECISIONS REQUIRED:

That the Standard Charge for Local Authority Older People residential care homes be increased from £641.21 to £654.06 for Mainstream beds and from £863.43 to £884.17 for EMI beds.

For residents placed by this authority into our own Local Authority Homes the effective date for the new rates is 28th June 2021. For those residents placed in our homes by other Local Authorities the effective date for the new charges to those authorities is the 12th April 2021.

REASONS:

Adults in residential accommodation are required to contribute to the cost of their care. Where they have sufficient resources, they are required to pay the full cost of their accommodation, known as the Standard Charge which is calculated annually based on the full cost to the authority of providing the accommodation.

LOCAL AUTHORITY RESIDENTIAL CARE STANDARD CHARGE FOR 2021-2022

There are currently 7 homes with a total of 248 beds in Carmarthenshire County Council's own residential homes. The overall budgeted costs for running the Authority's residential homes together with the number of beds available and the occupancy levels are the determining factors in calculating the annual Standard Charge.

In previous years, the calculation for the Standard Charge was actioned later in the year to wait for confirmation of the pay award. As the pay award confirmation was very late in 2020-2021 and looks likely to be post-April in 2021-2022, the calculation is using the Revenue Budget Strategy projection of 2.5%.

For 2021-22 there has been no change in the number of Local Authority beds. Staffing costs have increased due to an estimated pay award of 2.5% in line with the Council's Revenue Budget Strategy and extra costs pressures on supplies and services of 2%. There are no proposed savings efficiencies reducing the budgets.

As a result, the charge for mainstream beds will increase by 2.00% and EMI beds by 2.40%.

Recommendation

The Standard Charge for Local Authority Older People residential care homes be increased from £641.21 to £654.06 for Mainstream beds and from £863.43 to £884.17 for EMI beds.
