> Representations were received objecting to the application which reiterated the objection points detailed within the Head of Planning's written report with the main concerns relating to:-

- The integrity of the plans,
- The adverse impact on amenity of surrounding residents
- The change in levels as a result in the development being overbearing on adjacent properties causing a loss of privacy particularly in relation to plot 1.

The Agent and the Development Management Officer responded to the issues raised.

It was raised that some members had difficulty hearing the all the objector's points due to poor sound quality, the Chair, after receiving the representations from the objectors present by e-mail, afforded Committee Members with the opportunity to hear all objections by reading them audibly to the Committee.



Following the concerns raised in relation to the objections regarding the loss of privacy and the elevation of the development, it was proposed that the Committee undertake a site inspection in order to gain a better understanding of the impact on the adjacent properties. This was duly seconded.

In order to seek legal advice, the Chair adjourned the meeting for 15 minutes at 11:45am. At 12:00pm, the Committee reconvened and in light of the objections, it was proposed that the Committee undertake a site visit subject to the Welsh Government Covid/Regulations and following a risk assessment undertaken by this Authority.
