DELEGATING AUTHORITY TO OFFICERS

At the meeting of the Licensing Committee held on the 19th May 2016, members resolved that consideration be given to the possibility of delegating authority to Officers to issue certain licenses under delegated Authority.

1.Drivers over 70 years of age

Currently where applicants reach the age of 70, they must appear before the Licensing Committee in order for their Licence to be issued. This is as a result of <u>Condition 25</u> of the Council's Conditions of Licence for Hackney Carriage and Private Hire Dual Drivers which states that "The driver shall be at least twenty one years of age and must not be older than seventy years of age"

2.Exemption from Condition 5a and 5b of the Council's Licence Conditions for Private Hire Vehicles

Currently where an application is made to operate a vehicle for executive type hire, applicants appear before the Committee to request an exemption from Condition 5a and 5b of the Council's Licence Conditions for Private Hire Vehicles, namely that the applicant be not required to display door stickers and a licence plate on the rear bumper of the Vehicle. In order to be granted this exemption, applicants must submit a business case to the authority and appear before committee for each vehicle they request this exemption.

The Licensing Authority representative referred to his representations as detailed within Appendix C to the report. All parties were afforded the opportunity of questioning the Licensing Authority representative on his representation.

The Dyfed Powys Police representative outlined his representations as detailed within Appendix D to the report. He referred to the fact that Lammas Street was identified as a hotspot for anti-social behaviour in 2007 and it has remained a hotspot since that time. Lammas Street became busier in 2013/14 and following concerns regarding crime and disorder and anti-social behaviour an incident report was undertaken on Lammas Street. One of the main findings was that there was a noticeable increase in crime and disorder and anti-social behaviour in 2014. And between May 2013 and July 2015 there was a definitive correlation between crime and disorder and late night entertainment on Fridays and Saturdays. He stated that, whilst there were no crime and disorder incidents recorded against the premises, their concerns related to the location of the premises and the levels of anti-social behaviour and crime and disorder in the area. In view of the problems being experienced, the Police have asked for a cumulative impact policy to be adopted for the area. He requested that, should the Sub-Committee be minded to approve the application, suitable conditions be imposed like those imposed on other establishments with similar hours.

All parties were afforded the opportunity of questioning the Police representative on his representation.

The applicant's representative thereupon addressed the concerns and issues raised and advised that the company and their tenant wholeheartedly support any effort to reduce crime and disorder in the area. He stressed that the problems

referred to by the police occurred at the far end of Lammas Street and were due mainly to the late opening of the fast food outlets. He pointed out that good management has shown that the Drovers can operate successfully in Lammas Street. With regard to imposing conditions on the licence, he did not believe that this was necessary and if the police were concerned about that then they would have raised it previously. He asked the Sub-Committee to judge the application on the performance of the premises. There have been no issues or complaints and they have proved that they can operate responsibly and they will continue to do so. They were not asking for parity with other establishments in the area who are open until 4.00 a.m.

All parties were afforded the opportunity of questioning the evidence submitted.

The Sub-Committee thereupon

UNANIMOUSLY RESOLVED to retire into private session in order to receive legal advice pursuant to Paragraph 16 of Schedule 12A of the Local Government Act.

REASONS

In coming to its decision, the sub-committee made the following findings of fact;

- 1. The premises was located in a street identified in the Council's statement of licensing policy as a hot spot of alcohol related crime and disorder.
- 2. The Police object in principle to the application on crime and disorder grounds.
- 3. No evidence was presented of any alcohol related crime and disorder at or directly related to the premises
- 4. There was only 1 recorded incident of defective management practice at the premises, which had resulted in a warning to the previous DPS.
- 5. The increased hours sought were less than terminal hour of licensed premises in the vicinity
- 6. The applicant had put in place CCTV, SIA registered door staff and staff training.

The sub committee attached weight to the views of the police and licensing authority and the absence of any representations from the other responsible authorities. It also took into account issues of crime and disorder in the vicinity of the premises, but not directly attributable to it.

The sub committee recognised that its decision must be based upon real evidence, and that concerns and fears about what might happen if the application were granted, where unsupported by such evidence, were not matters which they could properly take into account.

The subcommittee accepted the evidence of the police as to the level of crime and disorder currently present in Lammas Street. The sub committee accepted that the

premises had been well run and there was no history of crime and disorder at or related to the premises.

Whilst the sub committee acknowledged the concerns of the police that granting the application would risk increasing current problems in the street it noted that the extended hours sought wee still significantly less than those enjoyed by other nearby premises.

The sub committee accepted the evidence of the police that increased migration to and retention of drinkers in Lammas Street was likely to result from granting this application and that this would impact upon the overall level of alcohol related crime and disorder in the street.

On the balance of probabilities the sub committee therefore found that to grant the application as requested would be likely to undermine the licensing objective of preventing crime and disorder.

However the sub committee was satisfied that this could be addressed by the adding of additional conditions to the premises licence rather than refusing the application outright.

On the balance of probabilities the sub committee was satisfied that the conditions agreed between the parties are proportionate, and appropriate for the promotion of the licensing objectives.

In coming to its decision, the Sub-Committee made the following findings of fact;

- 1. There was no previous history of complaints or enforcement action in relation to the premises;
- 2. Neither the Police nor the Licensing Authority objected in principle to the granting of the application;
- 3. Both the Police and Licensing Authority believed that the operating schedule did not sufficiently promote the Licensing objectives;
- 4. The applicants had accepted the additional licence conditions proposed by the Police and licensing authority;
- 5. None of the other responsible authorities (in particular Public Health Services) had made representations;
- 6. No evidence had been received of any significant alcohol related crime and disorder in the vicinity of the premises;
- 7. Any nuisance arising from the use of the smoking area would be likely

to only affect the adjoining residential premises no.19;

8. The parking restrictions operating in the road outside the premises permitted loading and unloading on the street.

The Sub Committee attached weight to the views of the police and the licensing authority and the absence of any representations from the other responsible authorities, particularly public health services.

The Sub Committee recognised that its decision had to be based upon real evidence, and that concerns and fears about what might happen if a licence were granted, where unsupported by such evidence, were not matters which it could properly take into account. Equally, issues of need or the availability of other sources of alcohol in the area were not matters which the Sub Committee could take into account.

The Sub Committee noted that it could not duplicate other regulatory regimes.

In approaching its decision the Sub Committee had been mindful that it may only consider matters relating to the promotion of the 4 licensing objectives, namely;

- 1. The prevention of crime and disorder
- 2. The prevention of public nuisance
- 3. Public safety
- 4. Protection of Children from Harm

Whilst the Sub Committee found the objectors evidence to be credible and genuine, it could not ignore the fact that their concerns were not supported by the various responsible authorities, none of whom had objected to the grant of a licence in this case.

In particular, the Sub Committee was concerned about the impact of smoke nuisance from the smoking area upon the residents of number 19, but accepted that this would amount to a private rather than public nuisance. Similarly, the genuine concerns about on-street deliveries were more appropriately a matter for Traffic Management officers as they applied to any business operating out of the premises, rather than specifically to licensed premises.

The Sub Committee did share many of the objectors concerns, but was of the view that these matters were appropriately dealt with by other legislation such as fire safety legislation and environmental health legislation.

The Sub Committee therefore was satisfied on the balance of probabilities that to grant the application, in its amended form, would not undermine any of the licensing objectives and that therefore it was appropriate to grant a licence subject to the additional agreed control measures.

- 3. That the premises would operate as a general store and that alcohol sales would form one part of the business;
- 4. None of the responsible authorities objected in principle to the granting of the application;
- 5. The applicant has agreed to the additional licence conditions requested by the police

- 7. No compelling evidence had been presented of alcohol related anti-social behaviour or crime in the vicinity of the premises;
- 8. The proposed operating and license hours were at odds with those specified in the planning consent applicable to the premises.

The Sub Committee attached weight to the views of the police and public health services, and the absence of any representations from any other responsible authority.

The Sub Committee recognised that its decision must be based upon real evidence, and that concerns and fears about what might happen if a licence were granted, where unsupported by such evidence, were not matters which they could properly take into account. Also the Sub Committee recognised that issues of need were matters that it could not take into account.

The Sub Committee found the evidence of the local residents to be credible and genuine, but was satisfied that the issues identified would be appropriately addressed by the control measures set out in the operating schedule and the additional conditions agreed between the applicant and the police.

The Sub Committee noted the discrepancy between the operating and licensable hours sought in this application and the planning conditions applicable to the property. The Sub Committee was satisfied that it should not refuse the application or limit the operating/licensable hours for this reason alone.

The Sub Committee had carefully considered the representations from Public Health services and was of the view that the proposed licence conditions were neither appropriate for the promotion of the licence objectives nor proportionate to the issues they sought to deal with because those issues were not directly related to the sale of alcohol, but rather to the general operation of a convenience store.

Therefore having regard to all the evidence the Sub Committee was satisfied that, on the balance of probabilities, that to grant the application on the terms agreed between the applicant and the police, together with the additional litter condition volunteered by the applicant would not undermine any of the licensing objectives.

3. PRIVATE HIRE VEHICLE LICENCE

The Committee considered an application from Mrs Julie Michelle Bury of M4 Services, 14 Hendre Road, Tycroes, Ammanford, Carmarthenshire, to be granted an exemption from Conditions 5a and 5b of the Council's Licence Conditions for Private Hire Vehicles for her BMW 218 Gran Tourer registration number M4 4WYR.

Mrs Bury had requested that, as she intended to operate this vehicle for air and sea port travel and executive hire only, that she be granted an exemption from Conditions 5a and 5b of the Council's Licence Conditions, namely that she be not required to display door stickers and a licence plate on the rear bumper of her vehicle. Mrs Bury had been previously granted this exemption for several vehicles operated by her.

Should the Licensing Committee agree to grant Mrs Bury an exemption from Conditions 5a and 5b of the Council's Licence Conditions for Private Hire Vehicles,

then the following conditions would be attached to the licence:-

that the licensed BMW 218 Gran Tourer registration M4 4WYR be (i) exempt from licence conditions 5a and 5b whilst being used for air and sea port travel and executive hire purposes, as outlined in the application by

Mrs Bury;

- that, should the vehicle be used for private hire other than air and sea (ii) port travel and executive hire, then the applicant shall immediately notify the Licensing Authority and the exemption shall cease in relation to such hirina:
- that the vehicle displays an identification disc on the front and rear (iii) windscreens, as specified by the Licensing Authority.

UNANIMOUSLY RESOLVED that the application submitted by Mrs Julie Michelle Bury for an exemption from conditions 5a and 5b of the Council's Licence Conditions for Private Hire Vehicles for her BMW 218 Gran Tourer registration number M4 4WYR be granted in accordance with the conditions detailed within the report.

4. PRIVATE HIRE VEHICLE LICENCE

The Committee considered an application from Mr Philip Ashley Jenkins of Ashley's Executive Cars, 2 Llys Pendderi, Bryn, Llanelli, Carmarthenshire, to be granted an exemption from Conditions 5a and 5b of the Council's Licence Conditions for Private Hire Vehicles for his BMW 520 Auto Estate registration number CP16 AUA.

Mr Jenkins had requested that, as he intended to operate this vehicle for executive hire only, that he be granted an exemption from Conditions 5a and 5b of the Council's Licence Conditions, namely that he be not required to display door stickers and a licence plate on the rear bumper of his vehicle. Mr Jenkins had been previously granted this exemption for vehicles operated by him.

Should the Licensing Committee agree to grant Mr Jenkins an exemption from Conditions 5a and 5b of the Council's Licence Conditions for Private Hire Vehicles, then the following conditions would be attached to the licence:-

- that the licensed BMW 520 Auto Estate registration CP16 AUA be (i) exempt from licence conditions 5a and 5b whilst being used for executive hire purposes, as outlined in the application by Mr Jenkins;
- that, should the vehicle be used for private hire other than executive hire, (ii) then the applicant shall immediately notify the Licensing Authority and the exemption shall cease in relation to such hiring;
- that the vehicle displays an identification disc on the front and rear (iii) windscreens, as specified by the Licensing Authority.

UNANIMOUSLY RESOLVED that the application submitted by Mr Philip Ashley Jenkins for an exemption from conditions 5a and 5b of the Council's Licence Conditions for Private Hire Vehicles for his BMW 520 Auto Estate registration number CP16 AUA be granted in accordance with the conditions detailed within the report.

5. APPLICATION TO RENEW A HACKNEY CARRIAGE/PRIVATE HIRE DUAL DRIVER'S LICENCE - MR KELVIN TREVOR JONES

Mr Jones was 72 years of age and Condition 25 of the Council's Conditions of Licensing for Hackney Carriage and Private Hire Dual Drivers states that "The driver shall be at least twenty one years of age and must not be older than seventy years of age".

Mr Jones had produced a medical certificate confirming that he was fit to drive a Hackney Carriage/Private Hire Vehicle.

The Committee thereupon

UNANIMOUSLY RESOLVED that the application by Mr Kelvin Trevor Jones to renew his Hackney Carriage/Private Hire Dual Driver's Licence be granted.

6. APPLICATION FOR THE GRANT OF A HACKNEY CARRIAGE/PRIVATE HIRE DUAL DRIVER'S LICENCE - MR PETER FREDERICK PALMER

The Committee considered an application from Mr Peter Frederick Palmer of Llainwern, Maesycrugiau, Pencader for the grant of a Hackney Carriage/ Private Hire Dual Driver's Licence.

Mr Palmer was 70 years of age and Condition 25 of the Council's Conditions of Licensing for Hackney Carriage and Private Hire Dual Drivers states that "The driver shall be at least twenty one years of age and must not be older than seventy years of age".

Mr Palmer had produced a medical certificate confirming that he was fit to drive a Hackney Carriage/Private Hire Vehicle.

The Committee thereupon

UNANIMOUSLY RESOLVED that the application by Mr Peter Frederick Palmer for the grant of a Hackney Carriage/Private Hire Dual Driver's Licence be granted.

FURTHER RESOLVED that a report be submitted to the Committee for consideration at the next meeting on the possibility of delegating authority to officers to process applications from persons over the age of 70.

7. APPLICATION TO RENEW A HACKNEY CARRIAGE/PRIVATE HIRE DUAL DRIVER'S LICENCE - MR PETER MORGAN SALMON

The Committee considered an application from Mr Peter Morgan Salmon of 7 Gwendraeth Town, Kidwelly to renew his Hackney Carriage/Private Hire Dual Driver's Licence. The Committee interviewed Mr Salmon with regard to his

The Committee considered an application from Mr Andrew Robert Davies of Flat 1, Black Lion Hotel, Pentre Road, St. Clears to renew his Hackney Carriage/Private Hire Dual Driver's Licence. The Committee interviewed Mr Davies with regard to his application.

The Public Health Services Manager recommended that Mr Davies' application be granted with a warning as to his future conduct.

UNANIMOUSLY RESOLVED that, in line with the Council's guidelines, the application submitted by Mr Andrew Robert Davies to renew his Hackney Carriage/ Private Hire Dual Driver's Licence be granted and that he be issued with a warning as to his future conduct.

9. APPLICATION FOR THE GRANT OF A HACKNEY CARRIAGE/PRIVATE HIRE DUAL DRIVER'S LICENCE - MR CHRISTOPHER PHILLIPS
