1. DECLARATIONS OF PERSONAL INTEREST.

No Declarations of Interest were made at the meeting.

2. APPLICATION TO VARY A PREMISES LICENCE, THE SQUARE, 3 CROSS INN BUILDINGS, WIND STREET, AMMANFORD, SA18 3DN

The Legal Services Manager briefed all present on the procedure for the meeting and advised the Sub-Committee that an application had been submitted by Mr M Coelho to vary the premises licence in respect of The Square, 3 Cross Inn Buildings, Wind Street, Ammanford to allow:

Supply of Alcohol: Friday and Saturday, 10:00 – 03:00

Bank Holiday Sundays,

Christmas Eve &

Boxing Day

Recorded Music Friday and Saturday, 10:00 – 03:00

Bank Holiday Sundays,

Christmas Eve &

Boxing Day

New Year's Eve 10:00 – 05:00

Opening Hours Friday and Saturday, 10:00 – 03:30

Bank Holiday Sundays,

Christmas Eve & Boxing Day

The Sub-Committee noted that the following documentation was attached to the report:

- Appendix A copy of the application
- Appendix B copy of the current premises licence



- Appendix C representations submitted by the Licensing Authority
- Appendix D representations submitted by Dyfed Powys Police
- Appendix E representations made by the Public Health Services
- Appendix F representations submitted by other persons objecting to the application

The Licensing Authority representative referred to his representations, as detailed within Appendix C to the report, and advised that subsequent to the report's publication, correspondence had been received from both the Dyfed Powys Police and the Public Health Services withdrawing their objections, following an agreement having been reached with the applicant on the imposition of revised conditions, copies of which were circulated at the meeting. Additionally, an e-mail dated 19th September, 2016 from the applicant clarifying a number of points in relation to The Square's capacity, rear door and installation of cctv was also circulated.

Having regard to the agreement reached between the applicant, the Police and the Public Health Services on the revised conditions, the Licensing Authority considered it would be appropriate for those conditions to be applied to the new licence, should the Sub-Committee be minded to grant the variation application.

All parties present were afforded the opportunity of questioning the Licensing Authority's representative on his submission.

A representation was received from an objector on behalf of local residents living in the vicinity of The Square regarding the current noise emanating from the premises and to the potential impact the granting of the variation for one additional hour's opening could have on their amenity. A Concern was also expressed on whether the premises was becoming a night club, especially having regard to the fact a previous (planning) application in the area for a night club had not been granted. In conclusion, the Sub-Committee was advised that most other premises within the area closed at 1.00 a.m.

All parties present were afforded the opportunity of questioning the objector on his submission.

A representation was received from the applicant in support of his application. He referred to concerns expressed regarding the rear door and confirmed that the majority of customers vacated the premises via the front door. With regard to concerns of noise, he confirmed that he had not received any complaints from either the Council or the Police, and that, possibly, any noise nuisance was being created by members of the public walking through the adjacent park abutting the residents' properties in the early hours. He referred to the application to vary the licence until 3.00 a.m., and advised that should the variation be granted, he was of the view the majority of patrons would leave the premises incrementally prior to that time, thereby, avoiding the current position where they all left at 2.00 a.m. He further commented on the Action Plan for the premises, introduced in 2014 following a police request, and advised that its introduction had resulted in the operation of the premises having improved.

All parties present were afforded the opportunity of questioning the applicant on his submission.



UNANIMOUSLY RESOLVED to retire into private session in order to receive legal advice pursuant to Paragraph 16 of Schedule 12A to the Local Government Act.

Following the adjournment, the Sub-Committee reconvened to advise of its decision and, having regard to relevant paragraphs of the Licensing Authority's Statement of Licensing Policy and the guidance issued by the DCMS and the Home Office. it was

RESOLVED that the application for the variation of the premises licence for The Square Ammanford be granted subject to the additional licence conditions agreed between the applicant and the responsible authorities REASONS

In coming to its decision, the Sub-Committee made the following findings of fact;

- 1. There had been a history of alcohol related crime and disorder at the premises, culminating in an Action Plan in 2014
- 2. Since the Action Plan was implemented, there had been no further problems at the premises
- 3. Neither the Police nor Public Health Services objected to the grant of the application in principle
- 4. Both the Police and Public Health Services requested the implementation of additional control measures to promote the licensing objectives
- 5. The applicant, police and public health had agreed additional conditions to be added to the licence to promote the licensing objectives.

The Sub-Committee had attached weight to the views of the police and public health services and found no reason to depart from their views.

The Sub-Committee recognised that its decision must be based upon real evidence, and that concerns and fears about what might happen if the application were granted, where unsupported by such evidence, were not matters which it could properly take into account.

The Sub-Committee accepted the evidence of the objectors regarding crime and disorder and noise nuisance in the vicinity of the premises. However it also accepted the evidence of the Police and Public Health Services that the licensing objectives could be promoted by the implementation of the additional control measures agreed with the applicant.

Accordingly the Sub-Committee was satisfied that to grant the application subject to the agreed conditions would not undermine the licensing objectives and that furthermore it was appropriate to grant the application subject to the agreed conditions in order to promote those objectives.

The Sub-Committee reminds the applicant that he must comply with all the additional conditions whenever making use of the additional opening hours granted

RESOLVED that, in line with the Council's guidelines, the application submitted by Mr Ernest Tudor Davies for the grant of a Hackney Carriage/Private Hire Dual Driver's Licence be granted, but that he be not issued with a warning as to his future conduct.

4. MR WAYNE SMITH RUSSELL - APPLICATION TO RENEW A HACKNEY CARRIAGE/PRIVATE HIRE DUAL DRIVERS LICENCE

In accordance with Minute 4 of its meeting held on the 8th September, 2016 the Committee considered an application from Mr Wayne Smith Russel of 29 Pentre Doc y Gogledd, Llanelli, to renew his Hackney Carriage/Private Hire Dual Driver's Licence.

The Committee was advised that correspondence had been received from Mr Russel, the previous day, advising that due to family circumstances he was unable to attend the Licensing Committee that day. Mr Russel had also conveyed within that correspondence an apology to the Council for not having advised it of his motoring convictions, as required under his licence conditions.

The Public Health Services Manager recommended that Mr Russel's application be granted with a warning as to his future conduct.

The Committee thereupon

RESOLVED

- 4.1 that Mr Russel's application for the renewal of his Hackney Carriage / Private Hire Dual Driver's Licence be considered in his absence
- 4.2 that, in line with the Council's guidelines, the application submitted by Mr Wayne Smith Russell for the renewal of his Hackney Carriage / Private Hire Dual Driver's Licence be granted and that he be issued with a warning as to his future conduct.

5. MR DAVID WILLIAM DAVIES - HACKNEY CARRIAGE/PRIVATE HIRE DUAL DRIVERS LICENCE

The Committee was informed that Mr David William Davies of 4 Morfa Lane, Carmarthen, was a licensed Hackney Carriage/Private Hire Dual Driver with the authority and that an issue had arisen with regard to his licence. The Committee interviewed Mr Davies with regard to that issue

The Public Health Services Manager recommended that Mr Davies be issued with a final warning as to his future conduct.



The Committee thereupon:

RESOLVED to retire into private session in order to receive legal advice pursuant to Paragraph 16 of Schedule 12A of the Local Government Act 1972.

Following the adjournment, the Committee reconvened to advise of its decision.

RESOLVED that, in accordance with the provisions of Section 61(1) of the Local Government (Miscellaneous Provisions) Act 1976 Mr David William Davies' Hackney Carriage/Private Hire Dual Drivers Licence be granted and that he be issued with a final warning as to his future conduct.

6. MR NEIL ASHLEY PALMER - APPLICATION TO RENEW A HACKNEY CARRIAGE/PRIVATE HIRE DUAL DRIVERS LICENCE

(Note: Councillor J.S. Williams, having earlier declared an interest in this item, left the Council Chamber during its determination by the Committee)

The Committee considered an application from Mr Neil Ashley Palmer of 46 Ffordd Aneurin, Pontyberem, Llanelli, to renew his Hackney Carriage/Private Hire Dual Driver's Licence. The Committee interviewed Mr Palmer with regard to his application.

The Public Health Services Manager advised that whilst it was considered Mr Palmer's application should be granted, it was also felt that grant should be suspended for a period of 7 days.

The Committee thereupon

RESOLVED to retire into private session in order to receive legal advice pursuant to Paragraph 16 of Schedule 12A of the Local Government Act 1972.

Following the adjournment the Committee reconvened to advise of its decision.

RESOLVED that, in line with the Council's guidelines, the application submitted by Mr Neil Ashley Palmer to renew his Hackney Carriage/Private Hire Dual Driver's Licence be granted, but that the licence be also suspended for a period of twenty four hours.

Reasons

The Committee, having regard to the evidence presented, was satisfied that the applicant was a fit and proper person to hold a licence. However, the Committee was also satisfied that a short period of suspension was necessary in this case, and reasonable in order to remind the applicant of his obligations. The Committee felt that the recommended 7 day period of suspension would be disproportionate.

7. MR DAVID KEITH MAYNARD - HACKNEY CARRIAGE/PRIVATE HIRE DUAL DRIVERS LICENCE

The Committee was informed that Mr David Keith Maynard of 2 Pontgoch, Bancyfelin, Carmarthen was a licensed Hackney Carriage/Private Hire Dual Driver



with the authority and that an issue had arisen with regard to his licence. The Committee interviewed Mr Maynard with regard to that issue. It was also advised of the contents of two letters received from the complainant in the matter together with Mr Maynard's written response.

The Public Health Services Manager recommended that Mr Maynard's Licence be suspended for a period of seven days.

The Committee thereupon:

RESOLVED to retire into private session in order to receive legal advice pursuant to Paragraph 16 of Schedule 12A of the Local Government Act 1972.

Following the adjournment, the Committee reconvened to advise of its decision.

RESOLVED that consideration of the complaint made against Mr Maynard be deferred to the next appropriate meeting of the Committee in order for officers to undertake further investigations and to afford the complainant the opportunity of addressing the Committee in relation to the complaint.

8. MR REGINALD JOHN DAVIES - HACKNEY CARRIAGE/PRIVATE HIRE DUAL DRIVERS LICENCE

The Committee was informed that Mr Reginald John Davies of Llwyncelyn Cottage, Waun Dyrfal, Llangadog was a licensed Hackney Carriage/Private Hire Dual Driver with the authority and that an issue had arisen with regard to his licence. The Committee interviewed Mr Davies with regard to that issue. It also received video evidence relating to the complaint made against Mr Davies together with a character reference from County Councillor A. James.

The Public Health Services Manager recommended that Mr Davies' Licence be revoked.

The Committee thereupon:

RESOLVED to retire into private session in order to receive legal advice pursuant to Paragraph 16 of Schedule 12A of the Local Government Act 1972.

Following the adjournment, the Committee reconvened to advise of its decision.

RESOLVED that, in accordance with the provisions of Section 61(1) of the Local Government (Miscellaneous Provisions) Act 1976 Mr Reginald John Davies be issued with a final warning as to his future conduct.

Reasons:

The Committee having regard to the evidence presented accepted that the word "reidad" had different meanings and that Mr Davies meant it as a threat to overcharge the complainant if he ever used Mr Davies' taxi. However, it was understandable that the complainant would interpret the word as a threat of violence. In light of what Mr Davies meant by the words used, his exemplary

record over 39 years as a licensed driver, the Committee was satisfied there's no reasonable cause to suspend or revoke his licence. A final warning however would be appropriate in the circumstances, as such behaviour to a public servant was unacceptable.

9. TO APPOINT A MEMBER TO SERVE ON LICENSING SUB COMMITTEE B

The Committee was advised that following Council's decision, at its meeting held on the 12th October, 2016 to appoint Councillor D.B. Davies as a member of the Licensing Committee, it would now be necessary for the Committee to appoint a member to fill the vacancy on Licensing Sub Committee B

RESOLVED that Councillor D.B. Davies be appointed to serve on Licensing Sub Committee B.

10. TO SIGN AS A CORRECT RECORD THE MINUTES OF THE MEETING OF LICENSING SUB-COMMITTEE "C" HELD ON 31ST AUGUST, 2016.

RESOLVED that the minutes of the meeting of Licensing Sub Committee 'C' held on the 31st August, 2016 be signed as a correct record subject to it being noted that Councillor K. Howell had tendered his apology for the meeting.
