## 5. MR DAVID SIMON WILLIAMS HACKNEY CARRIAGE/PRIVATE HIRE DUAL DRIVERS LICENCE

The Committee was informed that Mr David Simon Williams of 44 Pemberton Street, Llanelli is currently a licensed hackney carriage/private hire dual driver with this Authority and that an issue had arisen with his licence.

The Committee interviewed Mr Williams with regard to the issue.

# 6. MR PAUL ANTHONY DAVIES APPLICATION FOR THE GRANT OF A HACKNEY CARRIAGE/PRIVATE HIRE DUAL DRIVERS LICENCE

The Committee considered an application from Mr Paul Anthony Davies of 14B Murray Street, Llanelli for the grant of a hackney carriage/private hire dual drivers licence.

The Committee interviewed Mr Davies with regard to his application and issues raised by the Senior Licencing Officer.

The Senior Licensing Officer recommended that Mr Davies' application be refused.

UNANIMOUSLY RESOLVED that the application submitted by Mr Paul Anthony Davies for the grant of a Hackney Carriage/Private Hire Dual Driver's Licence be refused.
