**RESOLVED that, in line with the Authority's Home to School Transport Policy, the appeal be refused on the basis that A.W – R's home address was located within the statutory walking distance of the designated Local Education Authority School and that the walking route had been assessed as being suitable in accordance with Welsh Government Criteria.**
