An apology for absence was received from Mr F. Phillips.

Reference was made to the decision at the Committee's previous meeting for an action register to be included onto the normal agenda of each Committee and that the register be included on the agenda for the next normal meeting

4. DISPENSATION APPLICATION BY COUNCILLOR A DAVIES

The Committee considered an application submitted by County Councillor Ann Davies for the grant of a dispensation under the provisions of the Standards Committees (Grant of Dispensations) (Wales) Regulations to speak and make written representations to the Council's Advisory Panels undertaking a review of the Council's rural estate.

It was reported that a dispensation was sought as Councillor Davies had a personal interest in the review as her husband was currently a tenant on a Council farm which they had occupied since 1991, and that a reasonable member of the public with knowledge of those facts would be likely to conclude it would influence the Councillors View of the wider public interest when it came to that review.

It was reported that a dispensation was sought by Councillor Davies by virtue of Regulation 2(f) of the Standards Committees (Grant of Dispensations) (Wales) Regulations in that her participation was justified by her particular role and expertise. In addition, the Committee was advised that it may wish to consider her participation would also be relevant under Regulation 2(d) in that it would not damage public confidence

Following a discussion it was

UNANIMOUSLY RESOLVED that dispensation be granted under Regulations 2 (d) and (f) of the Standards Committees (Grant of Dispensation) (Wales) Regulations 2001 to Councillor A Davies to speak and make written representations on the review currently being undertaken of the Council's rural estate and the dispensation be granted for a period of six months.

5. DISPENSATION APPLICATION BY COUNCILLOR P H THOMAS

The Committee considered an application submitted by Community Councillor P.H. Thomas of St Ishmael's Community Council for the grant of a dispensation under the provisions of the Standards Committees (Grant of Dispensations) (Wales) Regulations to speak and vote in relation to Council business regarding the foreshore and cockling activities in the Three Rivers Estuary.

It was reported that a dispensation was sought as Councillor Thomas had a personal interest in the matter as he works in the cockling industry, and that a reasonable member of the public with knowledge of those facts would be likely to conclude it would influence the Councillors View of the wider public interest when it came to that review.

It was reported that whilst the Community Council had no decision making role on the use of the foreshore, the permitting of cockling activities and does not own any land affected by those activities they were the subject of frequent discussion at council meetings. Councillor Thomas was therefore seeking dispensation under Regulation 2(c)(d) and (f) of the Standards Committees (Grant of Dispensations) (Wales) Regulations



The Legal Services Manager advised the Committee that with regard to the grounds of Councillor Thomas' application, it should note that Regulation 2(c) was not relevant in this instance and therefore the application fell to be considered under Regulations 2(d) and (f)

The Committee having regard to the application, and in terms of consistency of decision meeting, felt that given the nature of Councillor Thomas' employment it would not be appropriate to grant dispensation to vote. It was however felt appropriate to grant dispensation to speak and to make written representations.

Following a discussion it was

UNANIMOUSLY RESOLVED that dispensation be granted under Regulations 2(d) and (f) of the Standards Committees (Grant of Dispensation) (Wales) Regulations 2001 to Councillor P.H. Thomas to speak and make written representations, but not vote, at meetings of St Ishmaels Community Council in relation to Council business regarding the foreshore and cockling activities in the Three Rivers Estuary, and the dispensation be valid until the end of the current electoral term.

EXECUTIVE SUMMARY STANDARDS COMMITTEE 7th MARCH, 2023

Code of Conduct Compliance by Town and Community Councillors

For several years, the committee has undertaken a data gathering exercise with Town and Community Councils aimed at establishing the level of compliance with the members code of conduct in those organisations.

The questions normally asked related to

- The number of declarations of interest made my councillors during the preceding municipal year
- 2. Whether the members and clerk had received code of conduct training during the preceding year

This information, combined with data regarding code of conduct complaints and dispensation requests gives the committee an overall picture of code compliance in the County.

Considering the provisions of the Local Government and Elections (Wales) Act 2021 regarding training for Town and Community Councils it is proposed that additional questions be added to this year's exercise, namely

- 1. Whether the Council has adopted a training plan for its members
- 2. Whether that plan has been published on the Council's website
- 3. Whether the plan includes a requirement for members to undertake code of conduct training
- 4. Whether the plan has been implemented

It is therefore proposed that

- The data be collected via an online snap survey, which will reduce the administrative burden of the exercise considerably.
- The data be presented to the committee using a mixture of charts and graphs, ideally allowing comparison with the preceding municipal year.
- The target date for delivery of the report be the scheduled quarterly committee meeting in December 2023.

EXECUTIVE SUMMARY STANDARDS COMMITTEE 7th MARCH, 2023

Code of Conduct Training for Town and Community Councillors

For several years the committee has organised code of conduct training sessions for Town and Community Councillors each summer. These have usually taken the form of 'in-person' sessions in County Hall, with the 2022 sessions also being accessible remotely. Both sessions were recorded, and the recordings provided to councils to aide in the training of those members who were unable to attend.

For the first time, the sessions in 2022 were all held during the working day. Across the 2 sessions attendance was comparable to previous years. Subsequent consultation with councils identified that whilst some councillors preferred an evening session others preferred a daytime one and overall, there was no appreciable demand for an additional session or for sessions to be held during the evening. This was particularly if the sessions were being recorded and the recordings made available for viewing later.

The following is therefore proposed

- 1. Officers organise 2 code of conduct training sessions for Town and Community Councillors to take place in June or July 2023
- 2. The sessions be held during normal office hours and be hybrid events, attended in person at county hall or remotely via Zoom or Microsoft Teams
- 3. The sessions be recorded, and the recordings made available to Town and Community Councils along with the training materials used.
