All staff will complete alcohol awareness training to ensure they understand their legal requirements in serving alcohol. This will help to promote all four of the licensing objectives.

**b) The prevention of crime and disorder**

Through staff training we will promote responsible drinking to help prevent crime and disorder and ensure they understand that they must not serve any persons that appear to be intoxicated (drunk). Equally, they must not serve someone if they think that the alcohol being purchased is intended for consumption by someone that appears to be intoxicated (drunk). Also, they understand that they must not serve any persons, even if they are of the legal age if they think the alcohol being purchased is intended for consumption by someone under the age of 18. Furthermore that they are aware that free drinking water is available upon request. In addition, The staff will be required to complete the refuse log form where a sale has been refused.

**c) Public safety**

Any alcohol served for consumption off the premises will be served within seal vessel or a plastic vessel.

**d) The prevention of public nuisance**

Through staff training we will promote responsible drinking to help prevent crime and disorder and they understand that they must not serve any persons that appear to be intoxicated (drunk). Equally, they must not serve someone if they think that the alcohol being purchased is intended for consumption by someone that appears to be intoxicated (drunk). Also, they understand that they must not serve any persons, even if they are of the legal age if they think the alcohol being purchased is intended for consumption by someone under the age of 18. Furthermore, that they are aware that free drinking water is available upon request. In addition, The staff will be required to complete the refuse log form where a sale has been refused.

**e) The protection of children from harm**

We will be operating Challenge 25 policy and provide staff training to ensure staff refuse to sell alcohol to anyone unable to supply adequate ID and assume they are not over 18 years old. The staff will be required to complete the refuse log form where a sale has been refused. I understand that anything other than refusal is breaching the Licensing Act 2003 and they understand that the only acceptable 'Proof of Age Identification' is a valid Photo card Driving Licence, a valid Passport, or a valid Proof of Age ID Card, which has to have the "PASS" hologram on it.

**NOTES ON DEMONSTRATING ENTITLEMENT TO WORK IN THE UK**

*Continued from previous page...*

**Entitlement to work/immigration status for individual applicants and applications from partnerships which are not limited liability partnerships:**

A licence may not be held by an individual or an individual in a partnership who is resident in the UK who:

- does not have the right to live and work in the UK; or
- is subject to a condition preventing him or her from doing work relating to the carrying on of a licensable activity.

Any premises licence issued in respect of an application made on or after 6 April 2017 will become invalid if the holder ceases to be entitled to work in the UK.

Applicants must demonstrate that they have an entitlement to work in the UK and are not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity. They do this in one of two ways: 1) by providing with this application copies or scanned copies of the documents listed below (which do not need to be certified), or 2) by providing their 'share code' to enable the licensing authority to carry out a check using the Home Office online right to work checking service (see below).

**Documents which demonstrate entitlement to work in the UK**

- An expired or current passport showing the holder, or a person named in the passport as the child of the holder, is a British citizen or a citizen of the UK and Colonies having the right of abode in the UK [please see note below about which sections of the passport to copy].
- An expired or current passport or national identity card showing the holder, or a person named in the passport as the child of the holder, is a national of a European Economic Area country or Switzerland.
- A Registration Certificate or document certifying permanent residence issued by the Home Office to a national of a European Economic Area country or Switzerland.
- A Permanent Residence Card issued by the Home Office to the family member of a national of a European Economic Area country or Switzerland.
- A **current** Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder indicating that the person named is allowed to stay indefinitely in the UK, or has no time limit on their stay in the UK.
- A **current** passport endorsed to show that the holder is exempt from immigration control, is allowed to stay indefinitely in the UK, has the right of abode in the UK, or has no time limit on their stay in the UK.
- A **current** Immigration Status Document issued by the Home Office to the holder with an endorsement indicating that the named person is allowed to stay indefinitely in the UK or has no time limit on their stay in the UK, **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A birth or adoption certificate issued in the UK, **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A birth or adoption certificate issued in the Channel Islands, the Isle of Man or Ireland **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A certificate of registration or naturalisation as a British citizen, **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.

**Continued from previous page...**

- A **current** passport endorsed to show that the holder is allowed to stay in the UK and is currently allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity.
- A **current** Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder which indicates that the named person can currently stay in the UK and is allowed to work relation to the carrying on of a licensable activity.
- A **current** Residence Card issued by the Home Office to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights or residence.
- A **current** Immigration Status Document containing a photograph issued by the Home Office to the holder with an endorsement indicating that the named person may stay in the UK, and is allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A Certificate of Application, **less than 6 months old**, issued by the Home Office under regulation 18(3) or 20(2) of the Immigration (European Economic Area) Regulations 2016, to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence.
- Reasonable evidence that the person has an outstanding application to vary their permission to be in the UK with the Home Office such as the Home Office acknowledgement letter or proof of postage evidence, or reasonable evidence that the person has an appeal or administrative review pending on an immigration decision, such as an appeal or administrative review reference number.
- Reasonable evidence that a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence in exercising treaty rights in the UK including:-
  - evidence of the applicant's own identity – such as a passport,
  - evidence of their relationship with the European Economic Area family member – e.g. a marriage certificate, civil partnership certificate or birth certificate, and
  - evidence that the European Economic Area national has a right of permanent residence in the UK or is one of the following if they have been in the UK for more than 3 months:
    - (i) working e.g. employment contract, wage slips, letter from the employer,
    - (ii) self-employed e.g. contracts, invoices, or audited accounts with a bank,
    - (iii) studying e.g. letter from the school, college or university and evidence of sufficient funds; or
    - (iv) self-sufficient e.g. bank statements.

Family members of European Economic Area nationals who are studying or financially independent must also provide evidence that the European Economic Area national and any family members hold comprehensive sickness insurance in the UK. This can include a private medical insurance policy, an EHIC card or an S1, S2 or S3 form.

**Original documents must not be sent to licensing authorities.** If the document copied is a passport, a copy of the following pages should be provided:-

- (i) any page containing the holder's personal details including nationality;
- (ii) any page containing the holder's photograph;
- (iii) any page containing the holder's signature;
- (iv) any page containing the date of expiry; and
- (v) any page containing information indicating the holder has permission to enter or remain in the UK and is permitted to work.

If the document is not a passport, a copy of the whole document should be provided.

Your right to work will be checked as part of your licensing application and this could involve us checking your immigration status with the Home Office. We may otherwise share information with the Home Office. Your licence application will not be determined until you have complied with this guidance.

**Home Office online right to work checking service**

As an alternative to providing a copy of the documents listed above, applicants may demonstrate their right to work by allowing the licensing authority to carry out a check with the Home Office online right to work checking service.

To demonstrate their right to work via the Home Office online right to work checking service, applicants should include in this application their 9-digit share code (provided to them upon accessing the service at <https://www.gov.uk/prove-right-to-work>) which, along with the applicant's date of birth (provided within this application), will allow the licensing authority to carry out the check.

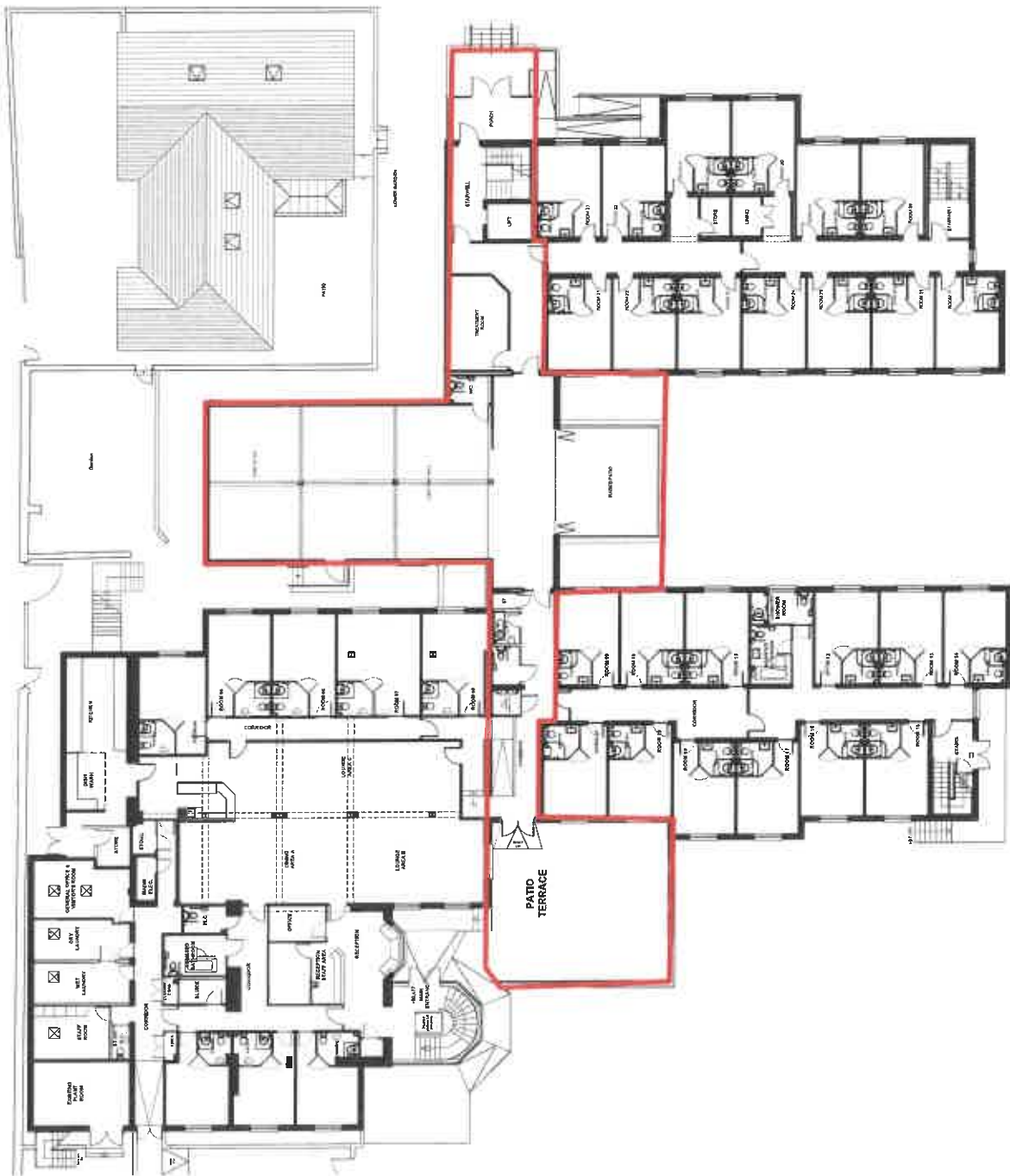

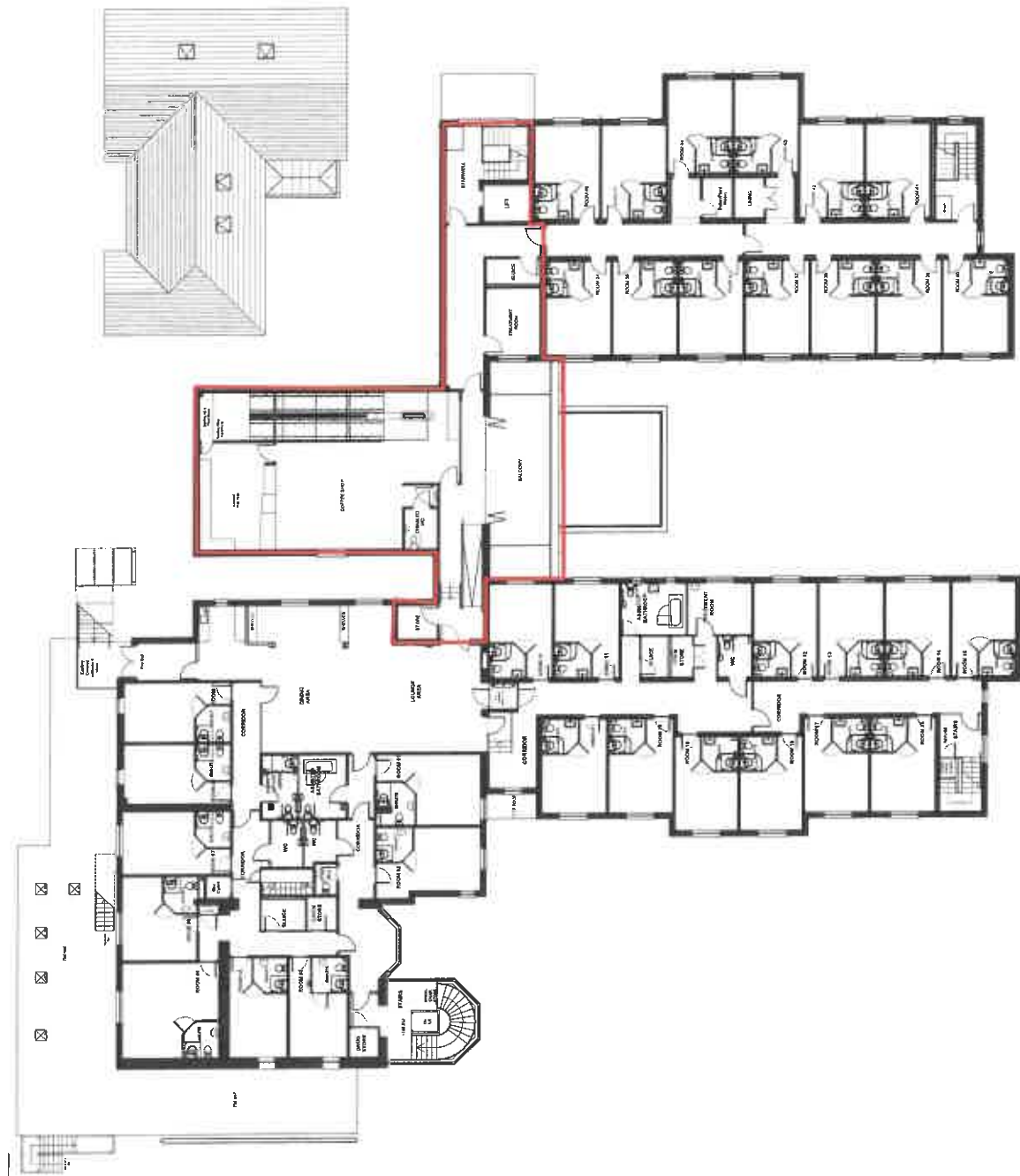

In addition Mr James indicated that an additional 30 parking spaces for visitors as well as additional staff parking spaces were being provided at the location and that those spaces would be accessed through the existing vehicle entrance at the front of the home. The new vehicular access at the rear of the premises is to be gated.

If the application is not amended as set out above, the licensing authority requests that the applicant produce a detailed assessment in accordance with paragraphs 5.1 – 5.4 on page 8 of the Statement of Licensing Policy for Carmarthenshire, detailing how they intend to promote the licensing objectives.

The Police have submitted a letter of representation in relation to the application. 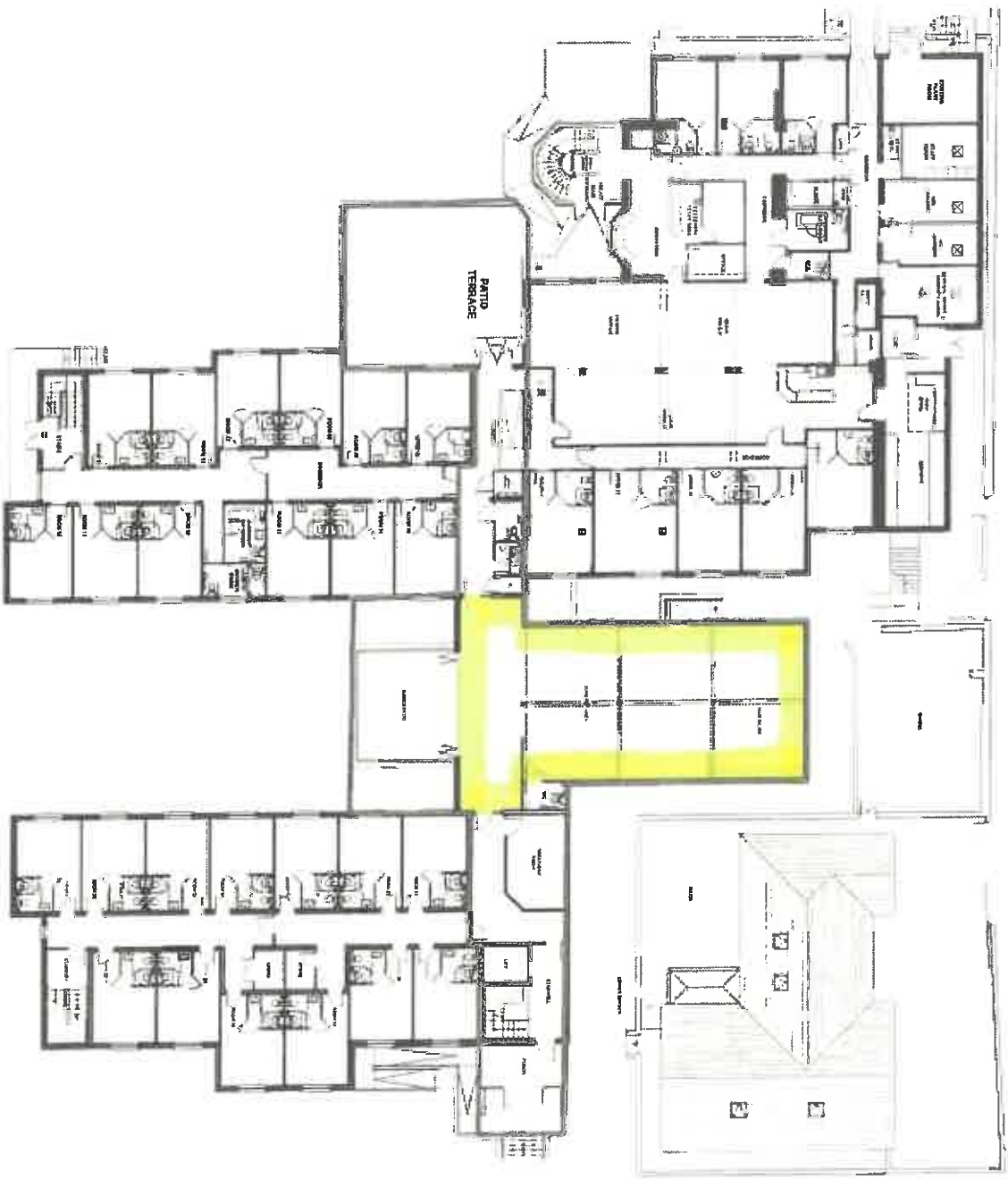



At the moment the children can ride their bikes around and play but with the increase in traffic and alcohol consumption this will be dangerous. Clos Maes Rhedyn is a small residents road which is hard to exit on to Cross Hands Road at the current time with the normal flow of traffic, this extra traffic will cause a lot of obstacles and difficulties when on school runs etc. Let alone devalue our houses.

The work traffic itself has caused issues this will be a major detriment and hazard to the estate and the families and children living here. We have only just been able to pass the work traffic on a school run whereas lorries or vans will struggle to get through. With this cafe and bowling alley opening this problem will continue and probably worsen.

Due to the parking at junctions I and I am sure other people have nearly had a collision due to not being able to see traffic coming down the road.

Please do not allow this licence to be issued. From past experience with the Gwernllwyn these time limits, rubbish and alcohol abuse will be a major issue to the families on the site.

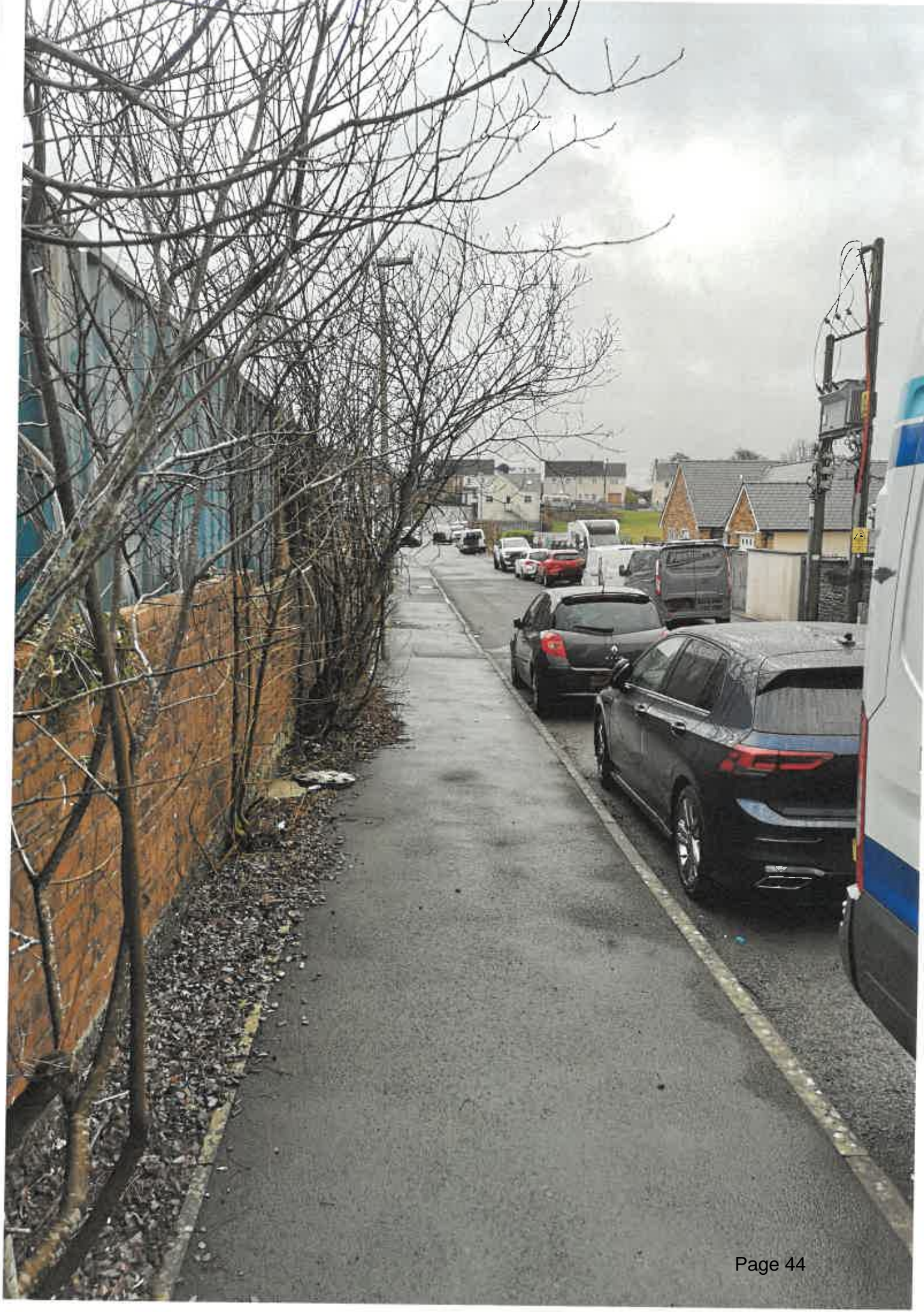

As you may be aware, prior to becoming a care home, Gwernllwyn was a night venue. As a resident of the adjacent street I remember those times vividly; where anti-social behaviour, criminality and drunken behaviour were common place each weekend. Additionally the noise disturbance and associated traffic meant disturbed sleep and quality of life.

To grant this license would directly contradict the sustainable development of cross hands as a family friendly place to live and work. Having young children, the thought of loud, drunken, anti-social behaviour impacting their wellbeing disgusts me. If this were granted, it would be unwise, irresponsible and completely shortsighted.

To Head of Housing and Public Protection,

We have been made aware that there is a public notice requesting an **alcohol licence** for Gwernllwyn Care Home from **Monday to Sunday 11am to 12 midnight**. I am writing this email to **OBJECT** to the request to sell alcohol from the hours mentioned above.

When we first moved into the estate over nine years ago, Gwernllwyn residential home was then a nightclub. We often encountered alcohol related problems over the weekends with regards to noise pollution; people shouting through the night, fighting and antisocial behaviour i.e. glass bottles being smashed, littering, urinating. Since it has been redeveloped into a nursing home, we have had no troubles/issues. It is a very quiet and peaceful estate for families, a lot who have young babies and children.

Also, there is a bowling alley and café being developed on site which we've been advised was supposedly meant for the residents but seems to now be open for members of the public which has been publicly advertised on Facebook that, and I quote 'aiming to open it by April'. I am concerned that when my neighbour spoke to a member of the council, they weren't even aware that it was being opened to the public.

This brings me to the supposedly temporary side access that was constructed for the purpose of building the extension to the rear of the nursing home for builders etc. When my neighbour questioned the site manager at the beginning of the work that has been going on for months, he was advised that as soon as the work had been completed the entrance would be closed up and used for emergency access only which would make sense as from the original plans show the access to the rear of the home would be accessed from the main Cross Hands Road to the front of the nursing home and down the right side of the building. We were made aware a couple of weeks ago that a request to keep this access open was put forward, (again, a piece of paper attached to a lamp post) if we did want to contest against it but as we thought this was to be used by visitors for the home, we didn't feel it necessary to oppose even though I'm close to where the entrance to the rear access is.

It looks as though that this was obviously planned for this entertainment venue. I have my concerns that as there is limited parking spaces at the rear that the foot path that has been constructed from the road to the rear of the home will be used for the public to park up along the curb of the street which for the past several months has been swamped with vans/cars/lorries which we haven't made any fuss over but has caused many issues with having visitors over, a driver reversing into one of the vans and having to drive up and on the curb at times due to the way they have parked. The Facebook advert states there will be booking for children's parties and school term parties, which you can imagine the number of vehicles that will be up and down this road and parked everywhere again causing frustration and inconvenience. Also being a safety concern for our young children who can't even ride their bikes along the pavement now and the same with push chairs as everyone is parked up on the curb.

Along with that and if alcohol is being reintroduced, I have major concerns that again this will lead to increase of noise pollution and anti-social behaviour as teenagers/young adults will have a place to congregate late into the night.

Subject: Objections for alcohol license in Gwernllwyn Care Home

Dear to whom it may concern,

I am a resident of Clos Maes Rhedyn at Gorslas (SA14 6SG) and I am writing this email with my concerns/objections regarding the alcohol license at Gwernllwyn Care Home.

My first concern is the residents of the care home. As a healthcare professional, a member of the public and a member of the community I believe that having an alcohol license within the same building as the care home is disgraceful, shameful and worrying. These residents are in the care home to receive care and not to be in an area where there is a great possibility of unrespectful behaviours, noise pollution and individuals taking great advantage of having an area to drink alcohol and abuse the facilities. This is a great shame for the community, it is an upsetting and a worry for all members of the public especially family and friends with loved ones in the care home. From a personal point of view, and having a grandfather that was in a care home - it would be heartbreaking to think that we would've been put in this situation. We had great respect, trust and dignity for the care home and staff and I believe that having this facility in Gwernllwyn care home especially during the unsociable hours would break the above 3 - respect, trust and dignity. This could then lead the staff to leave their jobs, meaning more unemployment within the community. Many residents of the care home are there towards the end of their life and to have to witness and live within an area where they do not have this choice is disgusting, in all honesty upsetting for these residents.

Another concern I have is an increase in antisocial behaviour. As a resident in the local area for the past few years, I have seen an increase in this and I believe that having these facilities in the care home is only going to make things worse especially as there is alcohol involved. Already, there is a noise pollution within the area - young people in their cars within the near car parks, screaming, shouting and loud music. These facilities would only make it worse as more people would be around the area.

We moved to live in this site less than 2 years ago, with no idea of these intentions and plans We moved here because we believe it was a family friendly, safe and convenient site/area for our jobs. With these plans undergoing and possibly going ahead we have considered moving from this area which would then affect our jobs and the education of my children especially my son who is about to start Gorslas school in April as it would be likely we would have to change schools. We have recently had a newborn baby, the thought of having somewhere with an alcohol license until midnight or at all is such a big concern. How is this right, a care home with an alcohol license has so many disadvantages and even affecting the young children and their education?!

As mentioned above I am a healthcare professional, and my husband works for the emergency services; we both understand and are witnessing such a stretched and pressurised service overall. Thus meaning, opening such a ridiculous facility with the elderly within a care home and young people using and abusing the system of alcohol being used, our system is only going to get worse, and fail as there is lack of resources and professionals within the area - this is a disaster waiting to happen.

My next concern is the vehicles and access to the rear of the care home, which affects our driveway and road outside the house. At the moment it is not the busiest of roads as it is not a drive through area for the public only for the ones living within the houses in the street and street above. This means that with the car park at the rear of the care home, more vehicles will be passing by; meaning it will be more like a main road and not a safe place. Again, a worry as we have such a young family and one of our reasons of moving here was not to be near a busy/main road. Again, this could lead to accidents leading to needing emergency services and as mentioned above there is major lack of resources.
