Elected again in 2012 - first elected in 1995-2008.

I continue to work on the past cases I highlighted last year plus any new issues that come up from time to time. The most prominent of which is the Park Howard case in Llanelli which is seemingly part of a larger project involving private enterprise.

These cases still include issues on planning and enforcement for which I declare an interest at every opportunity.

I have been involved for many years in the European case on the pollution of the Burry Inlet and Moderate Water Quality of Carmarthen Bay. I have represented the shell fishermen over the loss of such a valuable local industry.

Welsh Water is now working on a project that will last at the very least up to 2020 and will require 10 years monitoring and measurement for compliance issues to the existing European Directives including the Water Framework Directive. Welsh Water has thanked all the elected members of the Lliedi Ward for the work that has been done to aid them in their projects. The Officials in Europe taking the Loughor Estuary and Bury Inlet case forward to the European Courts have thanked the people who have assisted them in the case.

In my ward there have been housing issues requiring attention, planning enforcement issues that are on-going and will be once again the subject of investigation. I have represented small businesses with their problems.

I work closely with the PCSOs in my ward and report at meetings the problem areas that have been highlighted to me by the public.

I work closely with the Member of Parliament and the Assembly Member on the Flood Forum which has helped highlight all the problems with flooding, pollution and planning in our area and greater Llanelli. I have continued my involvement in the fight for doctor led A&E facilities at Prince Philip Hospital, Llanelli which are now in place.
