- Feed would need to be brought into the site for the animals
- A residential dwelling was to be erected in the countryside without having first proven financial viability

The Head of Planning and Development Control Officer responded to the issues raised

#### 6.2 RESOLVED

- 6.2.1 that Planning application PL00101 be granted, contrary to the Head of Planning's recommendation to refuse, on the basis the proposed development was deemed to be compliant with Local Development Plan Policies GP1, H1, H2 and TR3 and TAN 22 and that the proposed dwelling was not considered to be out of place when compared to other similar sized bungalows situated within the local community.
- 6.2.2 That delegated authority be granted to the Head of Planning to attach appropriate conditions to the planning consent

# PL/00101 Replacement single storey dwelling, Brodawel, Llanarthne, Carmarthen, SA32 8JD

A representation was made by the local Member supporting the application on the basis she considered the application fell within the definitions of Policies GP1, H1, H2 and TR3 of the Local Development Plan together with the provisions of TAN 22. By way of explanation, it was considered the proposed development in terms of its size and location to the existing property would not be out of keeping with similar sized properties in the area, it would result in the provision of off road parking, protection of trees and the replacement of an existing run down property with one fit for the 21st century.
