RECLASSIFICATION OF A476 CROSS HANDS

Purpose:

The Cross Hands Economic Link Road planned to be opened to traffic in October 2022. It is proposed that road classifications are revised to make the new link road the A476 and a section of the existing A476 given a B road classification.

This proposal has been discussed with Welsh Government who manage the Trunk Road network who are supportive of the proposal. Other minor modifications are also included.

If agreed, the reclassification will be coordinated with signage changes on the Trunk Road Network with interim arrangements in place until the reclassification.

Recommendations / key decisions required:

That the reclassification of the A476 is approved in principle.

Reasons:

To ensure effective traffic management and to ensure full benefits of the new road are taken.

EXECUTIVE SUMMARY CABINET 28 NOVEMBER 2022

Reclassification of A476 Cross Hands

The construction of the Cross Hands Economic Link Road is expected to be completed in October 2022 and the new road open to traffic. The new road will provide a high quality and more direct link between the A48 Trunk Road at Cross Hands and the A476 to the north of Gorslas.

The new road will take traffic out of an urban area and away from homes and a local school. It will also relieve pressure on the existing A48/A476 roundabout at Cross Hands which can be a source of traffic congestion and delay. The new road will play a key role in facilitating access to future development sites and improving access to existing sites.

To derive all of the potential benefits of the new road it is proposed to designate it as part of the A476 and to reclassify a section of the existing A476 through Gorslas as a 'B' class road. This reclassification will enable the route north from the A48 along the A476 to Llandeilo to be signed from the grade separated junction to the east of Cross Hands rather than through the existing roundabout.

Associated with the new road a short section of the B4556 (Norton Road) will also be redesignated along a new access onto the Link Road. Plans indicating the proposed highway classifications is attached along with a plan of the existing arrangement.

Welsh Government are supportive of the changes and recognise the benefits of reclassification in relieving pressure on the key roundabout junction at Cross Hands which can become congested during peak times.

The proposal would require changes to the existing signage on the A48 Trunk Road which Welsh Government hope to be in a position to implement in 2023/24. The reclassification will be brought forward in coordination with Welsh Government's signage changes. In the interim the existing road classification will remain.

Powers to reclassify roads are vested in local authorities. Advertising and consultation is not a requirement however new road numbers, which will be required for a short section of current A476, are generated by Welsh Government.

The reclassification of County roads is a power vested in local authorities. Details of this process are contained and referenced within the report.

Finance

Traffic sign changes on County roads will be funded from scheme budgets. Welsh Government will fund their own changes to Trunk Road signs which is expected in 2023/24.

Physical Assets

The new Economic Link Road will provide a significant improvement in traffic management in the area. The road will take pressure off the A48 Cross Hands roundabout which can be subject to congestion during peak traffic hours. The new link road also removes traffic from an existing section of the A476 which has many residential frontages and a local school nearby.

The Link Road also improves access to existing employment and retail sites and facilitates further development.
