3. CHAIR'S ANNOUNCEMENTS.

 The Chair announced that the Council had once again received accreditation from the White Ribbon Campaign in recognition of the work it had undertaken and planned to undertake. The White Ribbon Campaign aims to end male violence against women. As part of its commitment to the White Ribbon Campaign, the Chair announced that the Council would be flying the White Ribbon flag at County Hall and Town Halls in Llanelli and Ammanford and on the evening of 25th November 2022 County Hall would be lit. In addition, the promotions would be including in staff and Councillor newsletters.

5. PRESENTATION BY CHIEF FIRE OFFICER ROGER THOMAS, MID & WEST WALES FIRE AUTHORITY.

The Chair welcomed Chief Fire Officer Roger Thomas and Mrs Sarah Mansbridge, Mid and West Wales Fire and Rescue Service's Section 151 Officer, to the meeting.

The Chief Fire Officer gave an overview of the work of the Fire and Rescue Service. The presentation detailed information in respect of the work of the Fire Service and included the current operational and financial challenges.

The Council was informed that the Cabinet, at its meeting held on the 17th October 2022 (minute 7 refers), had considered the 2021/22 Annual Report of the Statutory Director of Social Care Services.

The report, presented by the Cabinet Member for Social Care and Health and the Statutory Director of Social Services, provided an overview of performance in 2021/22 as well as an assessment on future provision, together with strategic priorities for 2022/23. The report also outlined the challenges of an unprecedented year due to COVID 19 and highlighted those areas to be developed in the current year.

There was a statutory requirement for the Director of Social Services to report annually to Council on the delivery of services and performance as well as plans for the improvement of the whole range of social services.

Council members paid tribute to the staff working across the health and social services during what had been a challenging period and thanked the Statutory Director of Social Services for his dedication to the service and hard work in providing a comprehensive report.

The Cabinet Member for Social Care and Health and the Statutory Director of Social Services responded accordingly to the queries raised.

6.2. APPROVAL OF THE WEST WALES CARE PARTNERSHIP'S DEMENTIA STRATEGY

Council was informed that the Cabinet, at its meeting held on the 17th October 2022 (minute 7 refers), had considered the West Wales Care Partnership's Dementia Strategy. The Strategy, recommended for approval, had been produced in partnership with Carmarthenshire, Ceredigion and Pembrokeshire County Councils, the Health Board and third sector partners as well as people living with dementia, their carers and family members across West Wales.

The Cabinet Member for Social Care and Health, in presenting the report highlighted that the Strategy supported several key objectives within the Corporate Plan and the Council's Wellbeing Objective to support older people to age well and maintain dignity and independence in their later years. Furthermore, Carmarthenshire County Council's approval of the strategy was simultaneously going through the democratic process in Ceredigion and Pembrokeshire and had already been approved by the Health Board. Approval of the Strategy would enable services to be delivered in line with the needs of the community.

RESOLVED that the West Wales Care Partnership Dementia Strategy be approved.

6.3. WEST WALES CARE PARTNERSHIP POPULATION ASSESSMENT AND MARKET STABILITY REPORT

The Council was informed that the Cabinet, at its meeting held on the 17th October 2022 (minute 9 refers), had considered the West Wales Care Partnership Population Assessment and West Wales Care Partnership Market Stability Report.

The report summarised the approach that had been taken to produce the report and detailed the key findings and process for publication in order to comply with the Welsh Government guidance.



The Cabinet Member for Social Care and Health reported that Population Assessments had to be published once within each local government electoral cycle. The first Population Assessment had been produced in March 2017, the detail of which would be refreshed during 2022. Welsh Government had issued supplementary advice for Regional Partnership Boards regarding the production of the 2022 Population Assessment which had included the need to also produce a separate Market Stability Report.

Both documents, which would inform the West Wales Area Plan and in turn inform regional and local, commissioning intentions would be published by the West Wales Care Partnership on the online data portal for the region: Home -West Wales Care Partnership.

The Cabinet Member for Social Care and Health and the Statutory Director of Social Services responded accordingly to the queries raised.

Council considered the following Notice of Motion submitted by Councillor Alun Lenny and Councillor Kevin Madge:-

"Impact of the UK Government's Fiscal Policies on Council Funding

 Council states that further cuts in public spending by the UK Government, mainly resulting from the recent fiscal disaster of its own making, would make it immensely difficult to maintain services in the middle of a cost of living crisis. We agree with the WLGA that central government should step back and seriously consider the effect of its austerity policies on public services.



- Council calls on the UK Government to ensure that the Welsh Government gets sufficient funding to make Revenue Support Grant (RSG) settlements for councils at levels which will enable us to meet ongoing pressures and protect services.
- Council believes that a sufficient level of funding would enable councils to invest in local services in innovative ways in order to support growth, change lives for the better, and help residents through this distressing cost of living crisis."

The motion was duly seconded.

The proposer and seconder of the Motion were afforded the opportunity of speaking in support thereof and outlined the reasons for its submission, as set out in the Motion.

A number of statements were made in support of the Motion.

10. QUESTIONS BY MEMBERS:-

10.1. QUESTION BY COUNCILLOR KEVIN MADGE TO COUNCILLOR LINDA EVANS, CABINET MEMBER FOR HOMES & DEPUTY LEADER

"With the housing crisis in the Amman Valley and Carmarthenshire getting worse and private landlords making people homeless in addition to the prospect of higher interest rates in the next few months people will lose their homes. I would like to know from the Cabinet Member for Housing what action will be taken to bring the following properties back into public ownership in Garnant. They have been empty for years. In addition when are the 8 proposed new Council houses for Maesybedol going to be built?

- 1. 232 Cwmamman Road Garnant SA18 1LS
- 2. 14 Dynevor Road Garnant SA18 1NP
- 3. 9 Hendre Road Garnant SA18 2BL
- 4. 11 Hendre Road Garnant SA18 2BL"

Response by Councillor Linda Evans – Cabinet Member For Homes & Deputy Leader:-

First of all, I do share the concerns that Councillor Madge has raised about the housing crises which is impacting all of us across Wales. There is no doubt that the current demand is unprecedented, interest rates have increased, housing prices have increased and the new Renting Homes Act is going to be in force from the 1st December onwards.



This all contributes to the fact that landlords from the Private Sector are leaving the renting housing market at the moment. As a result, it is more important than ever to make sure that we increase the supply of affordable homes as well as managing demand. Thankfully, we are in a better position today than we were back in 2015. By now, we have 1520 of additional affordable homes that people can have access to. Members will be aware that we provide a range of options to increase supply by our new build programme, buying homes on the open market and making sure that we bring empty homes back into use as soon as possible. There are 88,473 homes in Carmarthenshire and at the moment there are 1,983 homes in the private sector that have been empty for more than 6 months.

Back in April, 2015 there were 2,671 empty homes in the County. These figures are testament to the success that the officers have had by working with owners and landlords. The total amount of empty homes has slowly reduced over the last few years, during 2021/22 we managed to get 152 empty homes back into use and Carmarthenshire was the second best in Wales. In 2020/21, we managed to get 168 homes back into use.

I would like to take the opportunity to thank Gareth Williams and his team for their tireless commitment. But of course, I am the first to admit and appreciate that there is more to be done and that is why we have set up an internal Improvement Board to make sure that we do everything we can to bring empty homes back into use.

We will very shortly be introducing a new empty homes plan which will lead to targeted intervention that we know from experience so far that taking action like this will lead to positive outcomes, either via advice and support or via enforcement.

We are also considering a council tax premium on empty homes. An intervention like this will also link with our wider strategic priorities of meeting the need for homes, supporting our regeneration initiatives and responding to empty homes that are causing a nuisance or that are attracting anti-social behaviour.

I hope this shows clearly our continuous priorities to bring empty homes back into use and can I ask kindly to Members, never to disregard how complex and how much time and emotion that goes into the process of dealing with empty homes. You have to deal with every property individually and with individual owners. Finally, with local matters that have been raised and the matter talking about specific properties, Councillor Madge is one of our most experienced Councillors and is aware that naming and discussing individual properties is not something appropriate or responsible to do in the Chamber. So, I will ask kindly to Councillor Madge to go through the usual process of raising local via the Democratic Services system and as I have said if any Councillor wants any more information or an explanation, I would be willing to organise a meeting between us and the appropriate Officers.

In relation to the houses that were supposed to be built in that area, I understand from Officers that has been responded to already. Thank you.



Supplementary Question by Councillor Kevin Madge.

My question is, can we have a debate in this Council with a plan, some of the matters raised in this question that we can all debate our housing needs in every ward. Because, every ward needs to be debated and can I have assurances that in due course we can have a major debate and I thank the Cabinet Member in what she says and I understand the system and I like some of us here get frustrated in progress. Can we have a major debate and that we can raise matters in our own wards for major debate. Thank you.

Response by Councillor Linda Evans – Cabinet Member For Homes & Deputy Leader:-

I understand that empty homes impacts everybody and I would be happy if we did not have any empty homes in the County, but that is not possible of course, because empty homes are always going to come round and round and empty homes have to be empty for at least 6 months before we are able to do anything about them.

I can tell you of the 1,900 I spoke about earlier, 55% of those have been empty for less than 6 months. So the process is a long process and where there is probate involved, large families, people moving abroad who own a house in this Country it is a huge process to deal with.

In relation to a debate, of course we have a new Chair on Scrutiny and I know that these debates will happen in scrutiny for any empty homes, then if you do have anything locally please come and speak to me and I will be happy to answer.

10.2. QUESTION BY COUNCILLOR HEFIN JONES TO COUNCILLOR EDWARD THOMAS, CABINET MEMBER FOR TRANSPORT, WASTE AND INFRASTRUCTURE SERVICES.

[Note: Councillor S. Davies having earlier declared an interest in this item, reiterated her declaration remained in the meeting.]

"There are residents of all ages in the rural ward of Llanfihangel Aberbythych, as in other wards county wide who, in the face of spiralling costs, will struggle to fund the running of private transport. Given these circumstances, the need to travel for work purposes, for medical appointments, and to access education and training, will the cabinet member responsible for transport please comment on exploring the utilisation of a bwcabus service - delivered by existing businesses - to plug the gap where the current provision is at best limited?"



Response by Councillor Edward Thomas – Cabinet Member for Cabinet Member for Transport, Waste and Infrastructure Services:-

Thank you for the question. The cost of living crises is affecting us all and indeed the Council. News stories of the weekend highlight the scale of the financial challenge facing Councils across the Country and we have heard further today about the pressures on the Authority.

Bus services across the County are facing the same challenges as energy and fuel costs increase. The sector is also experiencing a shortage or drivers and engineers. All adding to cost pressures in the sector at a time when we are facing budget restrictions. Currently, your ward is serviced by several routes to 276, 278, 279 and 284 local services unfortunately only run once a week the 280 which runs from Monday to Saturday and then the X14 Builth Wells to Carmarthen Services also covers your area but only on a Friday.

The Council has developed the Bwcabus services in areas of the County, but like all services investments is required to sustain the services. The Council is currently working with regional partners, the Welsh Government and Transport for Wales on the future plans for bus services as part of the South West Wales Metro. We are also working with community transport sectors to explore opportunities for the development of community transport in hard to reach areas of the County.

I will continue to press for government investment in rural areas to sustain connectivity and access to services for all our communities. Thank you.

Supplementary Question by Councillor Hefin Jones.

Thank you Councillor Thomas for the response. Given that you mention that the continued efforts to improve connectivity we need to be aware that 16-20 year olds 40% of them according to Welsh Governments own survey states that the public transport is the stumbling block for them to access further training. Councillor Thomas rightly outlined the difficulties around labour availability and increased costs. Acutely aware of the additional funding that was offered to keep busses on the road during Covid, my question would be is it now time that we take prudence into consideration and instead of seeing empty busses often running around the County. Mr Lee Waters MS has spoken at length about sustainability drive in the transport sector, can we ask then what is the state of dialogue between this Authority and the Deputy Minister for Climate Change, Mr Waters MS and his team for us to press ahead with this agenda. Thank you.

Response by Councillor Edward Thomas – Cabinet Member for Cabinet Member for Transport, Waste and Infrastructure Services:-

I can assure Cllr Jones that we are in dialogue with him, in fact the Leader Councillor Price and I have a meeting scheduled with Mr Lee Waters, Deputy Minister on 28th November where a lot of these matters will be raised and we will try and keep this Council in the loop.



The Council is working on the sustainability of the Bwcabus and the flexi model service provision, existing services has received European funding to make it possible and discussions on future investments and developments are live. I would reiterate that the public and community requires investment from the Welsh Government as part of a balanced transport system. The private car is the often the dominant mode of travel especially for those living in the rural areas.

The provision of transport is complex and of course it's a derived demand and often people will want to travel at the peak hours and as you quite rightly said buses are empty during the rest of the day. In the quieter off peak, we encourage people to use services which are available when the Bwcabus and flexible services over the more conventional services. The development of the metro for the whole of South and West Wales will be vital in support in the recovery of accessibility and connectivity across the region if the Welsh government is to achieve its ambitions target of model shift to more sustainable forms of transport. We will continue to press the case for investment within the County.

10.3 QUESTION BY COUNCILLOR KEVIN MADGE TO COUNCILLOR JANE TREMLETT, CABINET MEMBER FOR HEALTH & SOCIAL SERVICES.

"Could I have an update from the Cabinet Member on the following services and budgets at the Day Centre:-

- 1. Could I have an update on the attendance at the centre since the last County Council meeting on 28th September;
- 2. What is the current budget for Cwmaman Centre and what is the underspend for 2022/23;
- 3. Could you give me an update on the upgrading works which needs to be carried out at the centre kitchen;
- 4. Could I ask the Cabinet Member where are the elderly people in the Amman Valley in their 80s and 90s going to go when they can't heat their homes this winter when the day centre is closed."

Response by Councillor Jane Tremlett – Cabinet Member for Cabinet Member for Health and Social Services:-

Thank you for your question. As you know, I and officers have met with you in person and on Teams on many occasions pre, during and post pandemic to discuss this Local matter.

Points 1 2 & 3 are specific operational questions which officers are happy to answer in writing through the usual Democratic Services Cllrs. Inquiry route. As Cabinet Member I see all enquiries and responses and monitor issues raised and am happy to follow up with members should they wish.



Point 4 - As a Council we recognise with the cost-of-living crisis, and in particular escalating energy costs, Carmarthenshire residents are concerned about how they can heat their homes during this winter. The Council is inviting those who wish to spend the day in a warm, friendly and welcoming environment to do so in one of the three main libraries, Carmarthen, Ammanford and Llanelli where people will be able to enjoy refreshments, television, computers and newspapers and where staff will be on hand with advice about the cost of living and how to access potential support.

In addition, local communities can apply for funding to provide Warm Welcome spaces in their community halls and meeting places. New or existing projects can apply. The Warm Welcome Spaces scheme is funded through the Council's Poverty Fund. Applications can be made until 18th November and must be used by March 2023.

Maximum is £10,000 and Minimum is £1,000 and can be used for a number of purposes including development of Community Cafes where residents of all ages can meet and socialise and reduce social isolation; Growing projects, Fuel clubs etc., etc.

Supplementary Question by Councillor Kevin Madge.

I am afraid that the answer I have had is not acceptable. In the last September meeting the Cabinet member said that there were 20 clients so I would like it to be recorded in the minutes those questions need to be answered. It is for the whole of the Amman Valley not just me and my ward.

Are we saying that the Day Centre no longer exists, the question is that a library is more important now to warm up elderly people in the Amman Valley rather than a Day Centre? Is that now more important, a library? So elderly people in Garnant now have to go down to Ammanford to warm up in the library before they can go to a Day Centre? I am outraged at that answer, thank you.

Response by Councillor Jane Tremlett – Cabinet Member for Cabinet Member for Health and Social Services:-

I will stick with the answer I gave in the first instance, I have given you the opportunity to know what is available in your area and indeed across the whole of Carmarthenshire to the warm welcome places which will be an essential part of helping people through this very desperate winter. Thank you.
