Children's Services Action Plan	In the first quarter of 2023-2024 Children's services reported a projected overspend of £5.3 million against an overall budget of £23 million. As a result, a review was commissioned and led by the Statutory Director of Social Services to undertake an analysis in relation to the drivers of the demand and focus on areas where there has been significant overspend. A Transformation Plan has been developed from that analysis which aims to manage future demand and achieve a balanced budget.	To update the Committee on the Children and Families Transformation Programme.
Scrutiny Actions Update	This item will provide details on the progress made in relation to actions and requests arising from previous meetings.	To enable members to exercise their scrutiny role in relation to monitoring performance.
