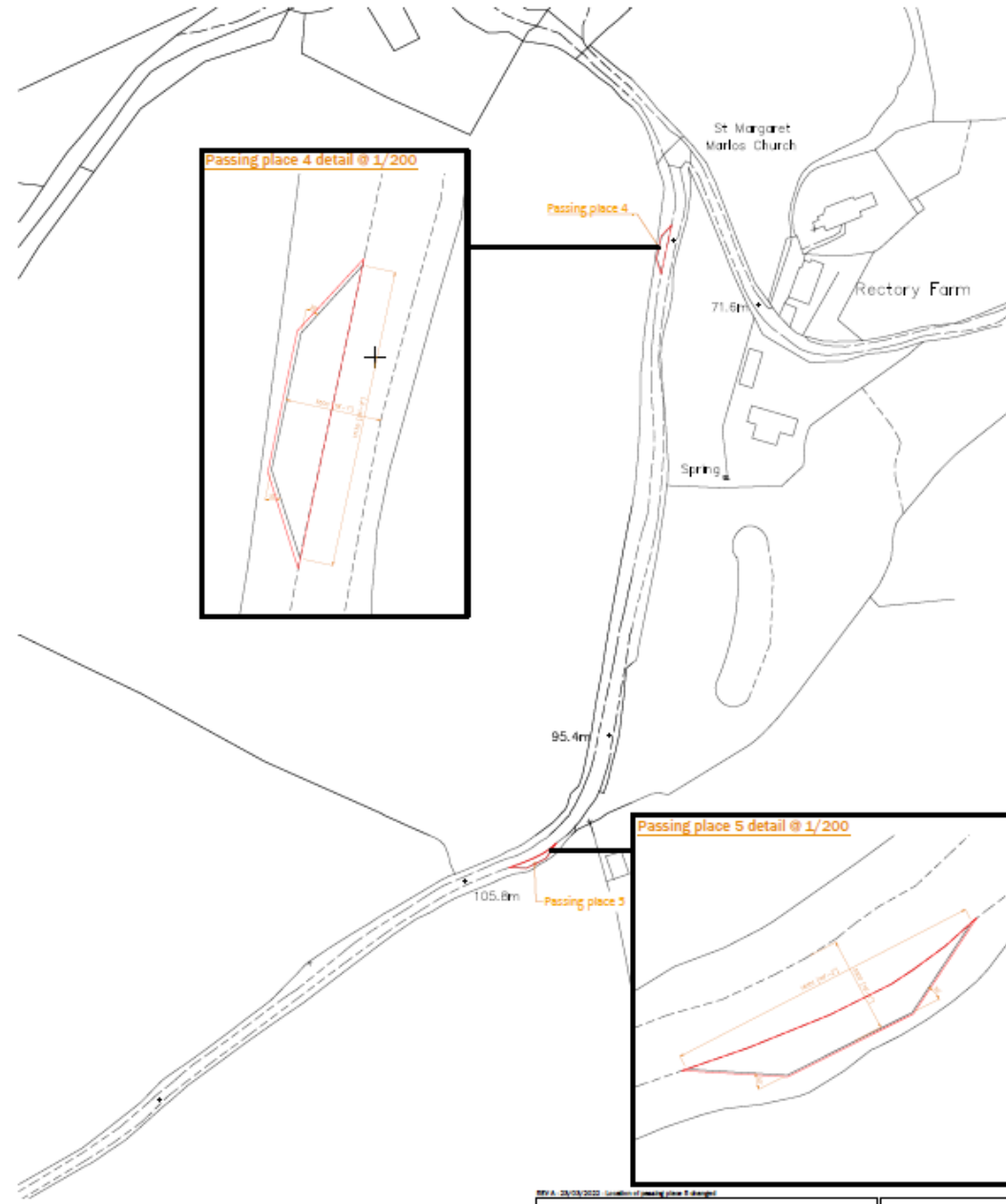


PL/02356 Location Plan including proposed passing places

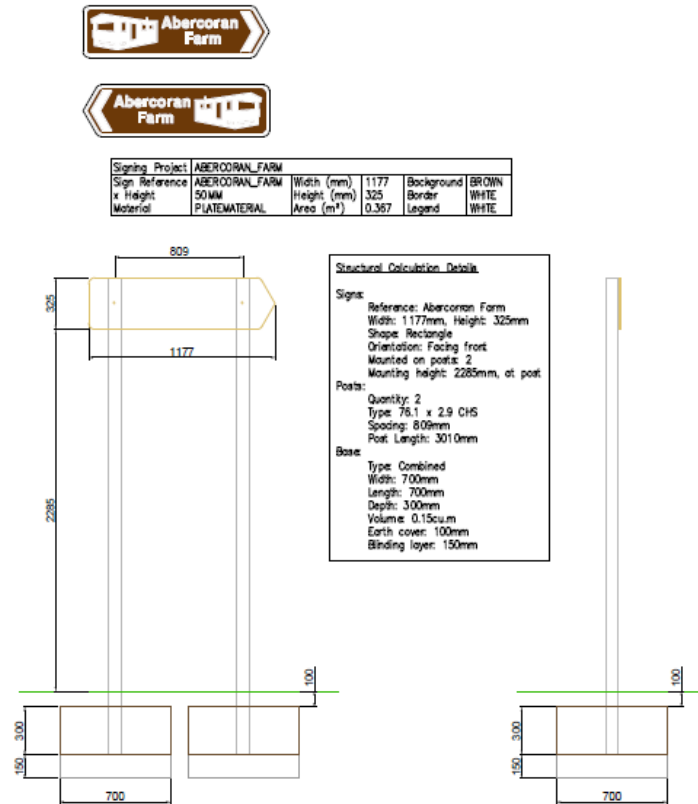
